Amends GS 143-318.14A(b)(2) as title indicates. Allows notice to be sent by electronic mail to Legislative Services Office and posted on the General Assembly's web site, sent by electronic mail to the legislative press accounts on the General Assembly domain; and notice to be sent to those who have requested notice by electronic mail. Act is effective 30 days after it becomes law.

S 561. LEGISLATIVE MEETING NOTICE PROCEDURE. Intro. 3/27/03. Senate committee substitute makes the following changes to 1st edition. Specifies that notice of meetings sent to those who have requested notice by electronic mail be sent by electronic mail.

S 561. NOTICE OF LEG. MTG. & COMM. & BD. APPOINTEES (NEW). Intro. 3/27/03. House committee substitute makes the following changes to 2nd edition. Rewrites GS 143-318.14A(b) to replace requirement of posting notice on press room door with requirement of notice mailed or sent by electronic mail to those who have requested notice, and to the Legislative Services Office, and that is posted on the General Assembly's web site. Rewrites GS 143-47.7 to (1) decrease from 60 to 30 days the time after acceptance of appointment by a person appointed to public office within which the appointing authority must file written notice of the appointment, (2) expand the required contents of the notice of appointment, and (3) set out a notice-of-appointment form. Repeals GS 143-47.8, an obsolete provision. Provides that act applies only to appointments made after the act becomes effective, which is 30 days after it becomes law.
