**S 669. CIVIL REMEDY FOR ANIMAL CRUELTY.** TO AMEND THE LAW REGARDING THE CIVIL REMEDY FOR PROTECTION OF ANIMALS, AS RECOMMENDED BY THE GENERAL STATUTES COMMISSION. Adds new GS 19A-1.1 prohibiting cruelty to animals. Amends definition of "animals" in GS 19A-1. Transfers certain exceptions to act's prohibitions from GS 19A-1 to 19A-1.1 and adds exceptions for activities conducted for livestock, poultry, or aquatic species production, for primary purpose of providing food, and for veterinary purposes. Amends GS 19A-3 to provide for the issuance of a temporary restraining order, and modifies GS 19A-4 to allow court to terminate defendant's ownership rights and transfer animal ownership to plaintiff.

(1) Amends proposed amendment of GS 19A-1(3) by defining the term "person" as having the same meaning as in GS 12-3 (2) Deletes proposed new GS 19A-1.1. (3) Renumbers proposed new GS 19A-1.2 ("Exemptions") as GS 19A-1.1 and makes stylistic, but not substantive changes to proposed section. (3) Deletes proposed amendment of GS 19A-3 and makes stylistic change to current GS 19A-3 (temporary restraining order). (4) Deletes proposed new GS 19A-3.1.
