S 859. CATAWBA RIVER BASIN BI-STATE ADVISORY COMM. (NEW). Intro. 4/3/03. Senate committee substitute makes the following changes to 1st edition. Replaces blank bill with bill adopting new GS 77-110 through -118 establishing the 14-member Catawba River Basin Bi-State Advisory Comm'n to provide guidance to governmental entities regarding the use and enhancement of the water and natural resources of the basin for citizens within the basin. Requires that Comm'n submit annual report on or before Oct. 1 of each year to the governors and legislatures of NC and SC. Appropriates \$25,000 from the General Fund for the 2003-04 fiscal year and \$25,000 for the 2004-05 fiscal year to the Comm'n to implement provisions of act. Effective July 1, 2003.

S 859. RIVER BASINS ADVISORY COMMISSIONS (NEW). Intro. 4/3/03. House committee substitute makes the following changes to 2nd edition. Changes name of "Catawba River Basin Bi-State Advisory Comm'n" to "Catawba/Wateree River Basin Advisory Comm'n." Increases membership of Comm'n to 15 (was, 14). Establishes 15-member Yadkin/Pee Dee River Basin Advisory Comm'n and gives Comm'n same powers and duties as Catawba Comm'n, but with respect to Yadkin-Pee Dee River Basin. Deletes appropriation of \$25,000 for 2003-04 and 2004-05 to Catawba Comm'n and specifically provides that act shall not be construed to obligate the appropriation of any state funds. Makes technical changes.
