**S 876. MENINGITIS IMMUNIZATION.** *TO REQUIRE ANY PRIVATE OR PUBLIC INSTITUTION THAT OFFERS A POSTSECONDARY DEGREE TO PROVIDE MENINGOCOCCAL IMMUNIZATION INFORMATION TO NEWLY ENROLLED STUDENTS IF THE INSTITUTION HAS A RESIDENTIAL CAMPUS.* Enacts new GS 116-260 as title indicates. Affected institutions are not required to provide meningitis immunization. Applies to 2003-04 and following academic years.

**S 876. MENINGOCOCCAL MENINGITIS IMMUNIZATION INFO. (NEW).** Intro. 4/3/03. Senate committee substitute makes the following changes to 1st edition. Amends GS 116-260(a) to provide that each student shall receive information (was, first-time enrollees only). Deletes GS 116-260(a)(1) through (3). Incorporates form required by GS 116-260(a)(3) into GS 116-260(a), but removes reference to students who are minors and requirement that students sign form, and adds requirement that information include recommendations from the National Centers for Disease Control and Prevention (CDC). Deletes provision in GS 116-260(b) requiring that student or guardian return signed form before student's enrollment at institution. Replaces GS 116-260(d), requiring that educational institutions consult with Dep't of Health and Human Services regarding preparation of informational materials, with provision stating that sec. is inapplicable if CDC no longer recommends vaccination. Makes technical changes.

Deletes previous provisions and inserts new provisions with title *TO REQUIRE PHYSICIANS WHO DISPENSE THE CONTROLLED SUBSTANCE BUPRENORPHINE FOR THE TREATMENT OF OPIATE DEPENDENCE TO REGISTER WITH THE DEPARTMENT OF HEALTH AND HUMAN SERVICES.* Adds new GS 90-101(a1) as title indicates, effective Oct. 1, 2003.
