S 934. DWI PROVIDER AUTHORIZATION FEES. *TO ESTABLISH A REGISTRATION FEE FOR THE AUTHORIZATION OF A PRIVATE FACILITY TO SERVE DWI OFFENDERS.* Amends GS 122C-142.1 as title indicates. Amount of fee is \$250, \$500, or \$750 depending on number of assessments. Effective July 1, 2003.

S 934. DWI PROVIDER AUTHORIZATION FEES. Intro. 4/3/03. House committee substitute makes the following changes to 1st edition. Amends GS 122C-142.1(a1)(3) to require that fees collected be used for program monitoring and quality assurance. Amends GS 122C-142.1(f) to increase substance abuse assessment fee from \$50.00 to \$75.00.

S 934. DWI PROVIDER AUTHORIZATION FEES. Intro. 4/3/03. House amendment makes the following changes to 2nd edition. Adds new subsection (f1) to GS 122C-142.1 (regarding alcohol and drug education traffic (ADET) schools). Provides that persons who have more than one offense for which a ADET school certificate of completion is required must pay the assessment fee for each certificate. However, the facility shall conduct only one substance abuse assessment and recommend only one ADET school or treatment program for all the required certificates of completion, and the person must pay only one school or treatment program fee.

July 17, 2003

S 934. DWI PROVIDER AUTHORIZATION FEES. Intro. 4/3/03. Conference report recommends the following changes to 3rd edition to reconcile matters in controversy. Deletes provision increasing the fee paid by a substance abuse services client for the substance abuse assessment necessary to obtain a certificate of completion required under GS 20-17.6. Provides that the adequacy of the current fee, set by GS 122C-142.1(f), be studied by the Joint Legislative Oversight Committee on Mental Health, Developmental Disabilities, and Substance Abuse Services, along with the type of testing provided, the treatment offered, the average duration of a program, the average cost of treatment, and the rates of recidivism. Changes effective date from July 1, 2003, to October 1, 2003.

DWI PROVIDER AUTHORIZATION FEES. *AN ACT TO ESTABLISH A REGISTRATION FEE FOR THE AUTHORIZATION OF A PRIVATE FACILITY TO SERVE DWI OFFENDERS AND TO REQUIRE THE JOINT LEGISLATIVE OVERSIGHT COMMITTEE ON MENTAL HEALTH, DEVELOPMENTAL DISABILITIES, AND SUBSTANCE ABUSE SERVICES TO STUDY THE SUBSTANCE ABUSE SERVICES OFFERED BY AN ASSESSING AGENCY AND THE ADEQUACY OF THE FEE IMPOSED FOR A SUBSTANCE ABUSE ASSESSMENT CONDUCTED BY AN ASSESSING AGENCY.* Summarized in *Daily Bulletin* 4/3/03, 6/18/03, 6/28/03, and 7/17/03. Enacted August 7, 2003. Effective October 1, 2003.
