H 1051. MACON-JACKSON REGIONAL AIRPORT AUTHORITY. *TO CONSOLIDATE THE EXISTING MACON COUNTY AIRPORT AUTHORITY AND THE EXISTING JACKSON COUNTY AIRPORT AUTHORITY TO CREATE A NEW MACON-JACKSON REGIONAL AIRPORT AUTHORITY.* Amends SL 1999-238 as title indicates. Repeals SL 1989-955 (establishing Macon County Airport Authority), except for section authorizing Rutherford Airport Authority to lease land to State for up to 30 years.

H 1051. MACON-JACKSON REGIONAL AIRPORT AUTHORITY. Intro. 3/31/05. House committee substitute deletes the substance of the 1st edition and replaces it with *AN ACT TO ENABLE THE CREATION OF A MACON-JACKSON REGIONAL AIRPORT AUTHORITY; TO LIMIT OPERATIONS OF SOME FIXED AND ROTARY WING AIRCRAFT; AND TO CHANGE THE MEMBERSHIP OF THE JACKSON COUNTY AIRPORT AUTHORITY.* As title indicates. Sets the permissible size of Macon-Jackson regional airport authority at between 5 and 9 members, as determined by boards of county commissioners of the two counties. Leaves to the commissioners decisions as to terms, succession, removal, and vacancies on airport authority. Leaves to discretion of each board of commissioners whether to dissolve current single county airport authority if regional authority created. Provides that no fixed wing or rotary wing commercial flights may start or end in Macon or Jackson county except from an airport approved by the F.A.A. and operated pursuant to GS Chapter 63. Provides that authorization for regional authority expires on January 1, 2007, if authority not created by that date. Amends SL 1997-22 (Jackson Airport Authority) to reduce size of authority from six to five members.

H 1051. MACON-JACKSON REGIONAL AIRPORT AUTHORITY. Intro. 3/31/05. House amendment makes the following changes to 2nd edition. Requires that the reduction in the membership of the Jackson County Airport Authority from six to five members be implemented by not filling any Authority vacancy that exists when bill becomes law or, if there is no vacancy at that time, by not filling the next Authority vacancy.
