H 1064. SULLIVAN ACT III. REGARDING THE PROVISION OF WATER SERVICE IN BUNCOMBE COUNTY. Effective June 30, 2005, requires that Asheville provide water to all Buncombe County consumers who are currently connected to waterlines maintained by the Asheville/Buncombe Water Authority and to those consumers who are connected to the waterlines in the future as long as the average daily usage of Asheville's water system does not exceed the 50-year minimum safe yields at certain listed facilities and reservoirs. Requires that the Buncombe County Board of Comm'rs or water district trustees maintain those waterlines that they own.

H 1064. SULLIVAN III—ASHEVILLE PUBLIC ENTERPRISES (NEW). Intro. 3/31/05. Senate committee substitute makes the following changes to 3rd edition. Completely rewrites prior edition to now provide as follows as to the City of Asheville only. Amends GS 160A-312(a), to remove provision that city cannot be held liable for failure to furnish any public enterprises outside the city limits. Amends GS 160A-312(b) pertaining to the rules for public enterprise systems. Enacts GS 160A-312(d), requiring a separate fund for a public enterprise. Amendments do not apply to the operation of public transportation systems or off-street parking. Amends GS 160A-31(a) and 160A-58.1(c), both requiring additional information in a petition for annexation. Effective June 30, 2005. Amendments to GS 160A-312 apply to the fiscal year 2005-06 and thereafter. Any assets, liabilities or equity of a public enterprise operated or held by the city during the fiscal year 2004-05 must be transferred to a separate fund in accordance with GS 160A-312, as amended, when the act becomes law. Amendments to GS 160A-31(a) and 160A-58.1(c) apply to petitions for annexation by the municipality on or after June 30, 2005.
