**H 1086. GENERAL ASSEMBLY POLICE JURISDICTION. *REVISING THE JURISDICTION OF THE GENERAL ASSEMBLY POLICE.*** Amends GS 120-32.2 to expand the jurisdiction of the State Legislative Building security force from within the state legislative buildings and grounds to within a one-mile radius of those buildings and grounds. Renames the security force the General Assembly Police. Makes conforming change to GS 120-32.3.

**H 1086. GENERAL ASSEMBLY POLICE JURISDICTION.** Intro. 4/4/05. House committee substitute makes the following changes to 1st edition: (1) rewrites title of act as *REVISING THE JURISDICTION OF THE GENERAL ASSEMBLY POLICE AND THE OATH OF OFFICE TO REFLECT THAT CHANGE, AND TO MAKE A TECHNICAL CHANGE*; (2) expands the geographic jurisdiction of the General Assembly to include the area of Raleigh within the innermost right-of-way of Interstate highway 440 and to include any part of North Carolina while accompanying a General Assembly member to, from, or during the conduct of the member's official duties, or while preparing for or providing security to a session of either house of the General Assembly or official events related to such a session; and (3) makes conforming change to GS 143-166.13 (those who are entitled to benefits under the Criminal Justice Training and Standards Act).

**H 1086. GENERAL ASSEMBLY POLICE JURISDICTION.** Intro. 4/4/05. House amendment makes the following changes to 2nd edition. Amends GS 120-32.2 to clarify that General Assembly special police authority granted in statute applies when police are on official duty.

**H 1086. GENERAL ASSEMBLY POLICE JURISDICTION.** Intro. 4/4/05. Senate committee substitute makes the following changes to 3rd edition. Modifies revisions to GS 120-32.2, which identifies the jurisdiction of the General Assembly special police, by deleting language identifying the State legislative buildings and grounds and adding language to include unincorporated parts of Wake County surrounded by the innermost right-of-way of Interstate 440. Adds provisions to allow General Assembly special police officers to arrest persons outside their jurisdiction when the person has committed an offense within the jurisdiction and the arrest is made during the person's immediate and continuous flight from the jurisdiction. Makes technical changes.
