Applies to contracts covering the transportation of property for compensation or hire by the motor carrier; entrance on property by the carrier for purpose of loading, unloading, or transporting property for compensation or hire; and services incidental to the foregoing activity, including storage. Enacts new GS 62-212(c) and (d) to provide that section does not affect a provision, clause, covenant, or agreement where the motor carrier indemnifies or holds harmless the contract's promisee against liability for damages caused by the motor carrier's negligence and to provide that the term "motor carrier transportation contract" does not include the Uniform Intermodal Interchange and Facilities Access Agreement or other agreements that contain the same indemnity provision as that Agreement.
