H 1213. EXPUNGE MULTIPLE CHARGES/OCCUR WITHIN 1 YR. TO PROVIDE THAT A PERSON CHARGED WITH MULTIPLE OFFENSES MAY HAVE THOSE CHARGES EXPUNGED IF THE ALLEGED OFFENSES OCCURRED WITHIN THE SAME TWELVE-MONTH PERIOD OF TIME AND THE CHARGES ARE SUBSEQUENTLY DISMISSED OR FINDINGS OF NOT GUILTY OR NOT RESPONSIBLE ARE ENTERED AT THE SAME TERM OF COURT. Enacts new GS 15A-146(a1) as title indicates. Provides that offenses need not arise out of the same transaction or occurrence or be consolidated for judgment. Requires court to order expunction if it finds that person has not previously received an expunction under section or under GS 15A-145 (expunction for first offenders under 18 years old) or GS 90-96 (expunction of first convictions of certain drug offenses committed by persons 21 years old and under) and person has not previously been convicted of any felony. Provides that person receiving an expunction may not subsequently be found guilty of perjury or of otherwise giving a false statement for failure to disclose expunged entries.
