**H 1269. STATE LAND NOT SUBJECT TO MUNICIPAL CONTROL (=S 669).** *TO REPEAL LEGISLATION THAT MADE STATE LAND SUBJECT TO MUNICIPAL PLANNING JURISDICTION AND PERMITTED THE IMPOSITION OF OVERLAY AND SPECIAL USE DISTRICTS ON STATE LAND WITHOUT THE APPROVAL OF THE COUNCIL OF STATE.*

**H 1269. THE STUDIES ACT OF 2005 (NEW).** Intro. 4/19/05. House committee substitute makes the following changes to 1st edition. Replaces bill with *AN ACT TO PROVIDE FOR STUDIES BY THE LEGISLATIVE RESEARCH COMMISSION, STATUTORY OVERSIGHT COMMITTEES, AND OTHER COMMISSIONS*. Substantially identical to 3rd edition of H 413 (digested in the August 24 *Daily Bulletin*) except: (1) authorizes Legislative Research Commission to study health care issues, including cost of, access to, and quality of care; (2) increases membership of House Study Commission on Capital Punishment from 10 to 15 members, provides that all commission members will be appointed by the Speaker of the House, requires submission of interim report to 2007 regular session of General Assembly, and provides that commission terminates when final report is submitted or upon convening of 2008 regular session of General Assembly, whichever is earlier; (3) deletes provisions establishing Study Commission on Global Climate Change; (4) deletes provisions establishing Study Commission on Trafficking of Illegal Handguns; (5) deletes provisions establishing Legislative Study Commission on the Budget of the Dep't of Public Instruction.

**H 1269. THE STUDIES ACT OF 2005.** Intro. 4/19/05. House amendments make the following changes to 2nd edition. Amendments #1 and #2 rewrite provisions relating to the Menhaden Study Commission as follows. Directs Joint Legislative Commission on Seafood and Aquaculture to study the management of menhaden and Atlantic thread herring. Study must address whether it should be unlawful to take menhaden or Atlantic thread herring with a purse seine off the shore of Brunswick and New Hanover counties during all or part of each year. Commission must report its findings and recommendations to the 2006 regular session of the General Assembly.

**H 1269. CHOWAN OCCUPANCY TAX CHANGES (NEW).** Filed 4/15/05. Senate committee substitute completely rewrites 3rd edition as *AN ACT TO AUTHORIZE CHOWAN COUNTY TO LEVY AND ADDITIONAL TWO PERCENT ROOM OCCUPANCY AND TOURISM DEVELOPMENT TAX AND TO MAKE OTHER ADMINISTRATIVE CHANGES*. Amends SL 1989-174 to authorize the Chowan County Board of Commissioners to levy an additional room occupancy and tourism development tax of up to 2 percent of the gross receipts from room rentals. Provides that both the existing and additional tax must be levied, administered, collected, and repealed as provided in GS 153A-155 (Uniform provisions for room occupancy taxes). Requires the Authority to use at least two-thirds of its funds to promote travel and tourism (primarily marketing activity) in Chowan County and the remainder for other tourism-related expenditures (may include tourism-related capital expenditures). Provides that the Authority receive the gross proceeds of the two taxes minus the cost to Chowan County of administering and collecting the tax (not to exceed 3 percent of the first \$500,000 of gross proceeds and 1% of the remaining gross receipts collected each year). Mandates that at least one-third of the Authority's members must be affiliated with businesses that collect the tax in the county and at least one-half must be currently active in county's travel and tourism promotion. Makes other conforming changes.
