ALLOWING THE NORTH CAROLINA BOARD OF ELECTROLYSIS EXAMINERS TO PROVIDE FOR THE CERTIFICATION OF LASER CLINICIANS AND LASER CLINICIAN INSTRUCTORS UPON MEETING CERTAIN REQUIREMENTS ESTABLISHED BY THE BOARD AND AUTHORIZING THE BOARD TO CHARGE FEES RELATED TO THOSE CERTIFICATIONS. As title indicates. Sets out requirements for person seeking endorsement as laser clinician or laser clinician instructor and for certification as a Board-approved school of laser, light source, or pulsed-light treatments. Substantially identical to S 1009, introduced 3/24/2005, except for terminology describing clinicians and instructors.

H 1330. AMEND ELECTROLYSIS PRACTICE ACT/FEES. Intro. 4/20/05. House committee substitute makes the following changes to 1st edition. (1) Throughout the bill changes word usage so that "licensure" refers to individuals and "certification" refers to schools. (2) Adds an amendment to GS 88A-4 making it a Class I felony with fine of \$5,000 per offensive to practice laser, light source, or pulsed-light treatments without a license. (3) Adds a \$75 fee for laser clinician instructor license renewal. (4) Makes the new felony provision effective December 1, 2005.

H 1330. AMEND ELECTROLYSIS PRACTICE ACT/FEES. Intro. 4/20/05. House amendment makes the following changes to 2nd edition. Modifies proposed GS 88A-19.1(a) to reduce from 600 to 100 the maximum number of hours the board may require a school of laser treatments to include in its curriculum in order to be certified.

H 1330. AUTHORIZE LICENSURE/ANESTHESIOLOGIST ASST'S (NEW). Filed 4/19/05. Senate committee substitute completely rewrites 3rd edition. Now authorizes North Carolina Medical board to license and regulate anesthesiologist assistants. Amends GS 90-11 to add qualifications for licensure and amends GS 90-15 to set a cap of \$150 for license and registration fees. Amends GS 90-18(c) to add provision of anesthesia services by a licensed anesthesiologist assistant to the list of activities not constituting practicing medicine or surgery. Enacts new GS 90-18.5, to set limits on the use of the title anesthesiologist assistant and direct the North Carolina Medical Board to adopt regulations governing the provision of anesthesia services by an anesthesiologist assistant under the supervision of a licensed anesthesiologist.
