H 1343. HEALTH INSUR./PROMPT PAY CORRECTION. TO CLARIFY THE PROMPT PAY STATUTE TO ALLOW PARTIES TO AGREE TO CERTAIN TERMS. Enacts new GS 58-3-225(n) prohibiting the amendment by contract of provisions set forth in GS 58-3-225 and providing that if insurers have contract provisions that are less favorable to providers than the provisions of GS 58-3-225, those contract provisions are superseded by the more favorable provisions of GS 58-3-225 and insurers must notify providers within 30 days of the superseded provisions. Applies to contracts executed on or after date of enactment.

H 1343. HEALTH INSUR./PROMPT PAY CORRECTION. Intro. 4/21/05. House amendment makes the following changes to 1st edition. Amends GS 58-3-225(b) to require insurers to send a response to a claimant within 15 days (was, 30) after receipt of a claim.

H 1343. DENTAL INTERN PERMITS (NEW). Filed 4/20/05. Senate committee substitute makes the following changes to 2nd edition. Replaces original bill with *AN ACT TO AUTHORIZE THE NORTH CAROLINA STATE BOARD OF DENTAL EXAMINERS TO EXTEND THE PERIOD IN WHICH A PERSON MAY RENEW AN INTERN PERMIT UNDER THE LAWS REGULATING THE PRACTICE OF DENTISTRY*. Amends GS 90-29.4(1) to allow the NC State Board of Dental Examiners to extend dental intern permits for additional one-year periods beyond the aggregate 72-month period that now limits the total amount of time for which these permits may be issued for any one intern. Allows extensions only if: (1) the permit holder has held an unrestricted dental license in a Board-approved state or jurisdiction for the five years immediately preceding the issuance of the intern permit; (2) the permit holder's approved employing institution appears before the board on the permit holder's behalf each time such an extension is considered; and (3) the permit holder has not attempted and failed a Board-approved written or clinical exam.
