Repeals GS 14-32.3(c) (regarding financial exploitation of an elderly or disabled person) and replaces it with new GS 14-112.2. Makes it a Class I, H, or G felony (depending on value of property involved) for a person who stands in a position of trust or confidence with an elderly or disabled adult (as defined in act) or who has a business relationship with an elderly or disabled adult to knowingly, by deception or intimidation, obtain or use an elderly or disabled adult's property with the intent to temporarily or permanently deprive the elderly or disabled adult of the use, benefit, or possession of the property or to benefit someone other than the elderly or disabled adult. Also makes it a Class I, H, or G felony for a person who knows or should know that an elderly or disabled adult lacks capacity to consent to obtain or use an elderly or disabled adult's property with the intent to temporarily or permanently deprive the elderly or disabled adult of the use, benefit, or possession of the property or to benefit someone other than the elderly or disabled adult. Effective December 1, 2005; applies to offenses committed on or after that date. Prosecutions for offenses committed before effective date are not abated.
