**H 1631. EXTEND CONTINUING BUDGET AUTHORITY (NEW).** Intro. 5/11/05. House committee substitute adopted July 14, 2005, makes the following changes to 1st edition. Completely rewrites 1st edition as *AN ACT AUTHORIZING THE DIRECTOR OF THE BUDGET TO CONTINUE EXPENDITURES FOR OPERATION OF GOVERNMENT AT THE LEVEL IN EFFECT ON JUNE 30, 2005; APPROPRIATING FUNDS FOR INCREASES IN THE AVERAGE DAILY MEMBERSHIP IN THE PUBLIC SCHOOLS AND IN UNIVERSITY AND COMMUNITY COLLEGE ENROLLMENT; DIRECTING THE STATE CONTROLLER TO TRANSFER OVERREALIZED DISPROPORTIONATE SHARE PAYMENTS TO NONTAX REVENUE; AND EXTENDING THE FINAL MATURITY OF CERTAIN GLOBAL TRANSPARK DEBT FROM JULY 31, 2005, UNTIL AUGUST 31, 2005.* Amends SL 2005-144 to extend until August 5, 2005, the expiration of the continuing budget authority provisions. Amends GS 147-69.2(b)(11), as amended by SL 2005-144, to extend the maximum maturity date for certain debt of the Global TransPark Authority from July 31, 2005, to August 31, 2005. Makes the following appropriations from the General Fund for the 2005-06 fiscal year: (1) \$125 million to the Department of Public Instruction to fully fund increases in public school enrollment; (2) \$7,802,343 to the Community Colleges System Office to fully fund enrollment increases; (3) \$72,753,678 to the UNC Board of Governors for increased enrollment; and (4) \$1,596,000 to the UNC Board of Governors to increase the State Contractual Scholarship Fund by \$50 per student in private college. Directs the State Controller to transfer \$11,109,834 in disproportionate share receipts to nontax budget code 19961 effective June 30, 2005.

**H 1631. EXTEND CONTINUING BUDGET AUTHORITY.** Intro. 5/11/05. House amendment makes the following changes to 2nd edition. Appropriates \$1,395,488 to the UNC Board of Governors to fund increase in the number of NC residents enrolling in State private colleges and universities. Provides that all funds appropriated by act from the General Fund are effective July 1, 2005. Makes technical change.
