H 1993. SUPPORT OUR TROOPS SPECIAL LICENSE PLATE. Filed 5/15/06. *TO AUTHORIZE THE DIVISION OF MOTOR VEHICLES TO ISSUE A SUPPORT OUR TROOPS SPECIAL REGISTRATION PLATE.* Adds new GS 20-79.4(b)(45a) as title indicates, plate issuance contingent upon receipt of 300 plate applications. Establishes additional fee of \$30, and requires that \$20 of each fee collected be transferred quarterly to NC Support Our Troops, Inc., to be used to provide assistance to the troops and their families.

H 1993. VARIOUS SPECIAL LICENSE PLATES (NEW). Filed 5/15/06. House committee substitute changes title to *AN ACT TO AUTHORIZE THE DIVISION OF MOTOR VEHICLES TO ISSUE THE FOLLOWING SPECIAL REGISTRATION PLATES: CAROLINA'S AVIATION MUSEUM, EMT, FOX HUNTING, LEUKEMIA AND LYMPHOMA SOCIETY, LUNG CANCER RESEARCH, N.C. CHILDREN'S PROMISE, PRINCE HALL MASONS, SUPPORT OUR TROOPS, AND U.S. EQUINE RESCUE LEAGUE.* Adds contents of HB 2683 (Carolina's Aviation Museum, filed 5/24/06), HB 2073 (EMT, filed 5/17/06), HB 2511 (Leukemia and Lymphoma Society, filed 5/24/06), HB 2072 (Lung Association, filed 5/17/06), HB 2690 (Prince Hall Masons, filed 5/24/06), HB 2459 (N.C. Children's Promise, filed 5/23/06), and HB 2245 (U.S. Equine Rescue League, filed 5/18/06) and adds subsections to GS 20-79.4(b) as title indicates.

H 1993. VARIOUS SPECIAL LICENSE PLATES. Filed 5/15/06. Senate committee substitute makes the following changes to 2nd edition. Amends GS 20-63(b) to add the NC State Parks plate and the Ducks Unlimited plate to the list of plates that are not required to depict the "First in Flight" design. Deletes Section 2 of 2nd edition, which would have recodified certain provisions of GS 20-79.4(b), and replaces it with Section 8, authorizing the Division of Legislative Drafting and Codification to renumber the subdivisions in GS 20-79.4(b). Amends GS 20-79.4(b) to authorize the issuance of the Greyhound Friends of NC, Gold Star Lapel Button, and Kappa Alpha Psi Fraternity special registration plates and to make issuance of those plates contingent upon the receipt of at least 300 plate applications. Further amends section to provide that the issuance of the following special registration plates are also contingent upon the receipt of at least 300 plate applications: Carolina's Aviation Museum, Leukemia & Lymphoma Society, Lung Cancer Research, NC Children's Promise, Prince Hall Mason, and US Equine Rescue League, in accordance with GS 20-81.12. Amends GS 20-79.7 to (1) eliminate the registration plate fee requirement for individuals who qualify for the Legion of Valor special registration plate; (2) establish an additional fee of \$20 for the Breast Cancer Awareness special plate, effective January 1, 2007, one-half to be used to support services for early detection of breast cancer; and (3) establish an additional fee of \$20 for the Greyhound Friends of NC special plate, one-half to be used for the care of retired greyhound racers. Enacts new GS 20-81.12(b2)(1i) to require that one-half of the revenue derived from the NC State Parks special plate be transferred quarterly to the National Heritage Trust Fund and one-half to the Parks and Recreation Trust Fund. Amends Section 8 of SL 2001-498 to remove the June 30, 2006, sunset on provisions authorizing the issuance of the Harley Owners' Group and Rocky Mountain Elk Foundation special registration plates. Makes conforming changes to title.
