**H 2208. DELAY CWMTF AMENDMENTS.** Filed 5/17/06. *TO DELAY THE EFFECTIVE DATE OF CHANGES APPLICABLE TO THE CLEAN WATER MANAGEMENT TRUST FUND CONCERNING THE ESTABLISHMENT OF UNIFORM CRITERIA FOR WASTEWATER, DRINKING WATER, AND STORMWATER GRANTS, AS RECOMMENDED BY THE ENVIRONMENTAL REVIEW COMMISSION.* Amends Section 12 of SL 2005-454 as title indicates, delaying effective date of the changes to the Trust fund from January 1, 2006, to January 1, 2007.

**H 2208. CWMTF AMENDMENTS (NEW).** Filed 5/17/06. House committee substitute makes the following changes to 1st edition. Deletes the provisions of the bill and substitutes an act *TO REPEAL THE REQUIREMENT THAT CERTAIN STATUTORY CRITERIA RELATED TO GRANTS FROM THE CLEAN WATER MANAGEMENT TRUST FUND FOR WASTEWATER AND STORMWATER COLLECTION AND TREATMENT PROJECTS HAVE PRIORITY OVER CRITERIA ESTABLISHED BY THE BOARD OF TRUSTEES OF THE CLEAN WATER MANAGEMENT TRUST FUND AND TO CLARIFY THE AUTHORITY OF THE BOARD OF TRUSTEES WITH RESPECT TO MATCH REQUIREMENTS IN CONNECTION WITH GRANT AWARDS.* Effective January 1, 2006, amends GS 113A-254(a1) to repeal the priority provision as indicated in the title and amends GS 113A-254(b) to delete the 20% cap on the amount of matching funds the Board of Trustees may require for a grant.

**H 2208. CWMTF AMENDMENTS.** Filed 5/17/06. Senate committee substitute makes the following changes to 2nd edition. Enacts new GS 113A-255(b2), effective retroactively to July 1, 2006, to provide that no member of the Board of Trustees of the Clean Water Management Trust Fund may serve more than two consecutive four-year terms or a total of ten years. Conforms title.

**H 2208. CWMTF AMENDMENTS.** Filed 5/17/06. Senate amendment makes the following changes to 3rd edition. Modifies proposed effective date of act by prescribing that the act does not apply to any person who is a member of the Board of Trustees of the Clean Water Management Trust Fund on June 30, 2006.
