H 2259. ELKIN OCCUPANCY TAX. Filed 5/18/06. *TO AUTHORIZE THE TOWN OF ELKIN TO LEVY A SIX PERCENT ROOM OCCUPANCY AND TOURISM DEVELOPMENT TAX.* As title indicates. Provides that net proceeds are remitted to the Elkin Tourism Development Authority, established in the bill. Directs authority to use at least 2/3 of the funds to promote travel, and tourism, and the remainder from tourism related expenditures.

H 2259. ELKIN/PILOT MOUNTAIN/DOBSON OCCUPANCY TAX (NEW). Filed 5/18/06. House committee substitute makes the following changes to 1st edition. Gives the towns of Pilot Mountain and Dobson the authority to levy a six percent room occupancy tax.

H 2259. VARIOUS OCCUPANCY TAXES (NEW). Filed 5/18/05. Senate committee substitute makes the following changes to 2nd edition. Changes title to *AN ACT TO AUTHORIZE THE TOWNS OF ELKIN, PILOT MOUNTAIN, DOBSON, AND AHOSKIE TO LEVY A ROOM OCCUPANCY AND TOURISM DEVELOPMENT TAX, TO CREATE A TAXING DISTRICT IN OCRACOCKE TOWNSHIP FOR THE PURPOSE OF AUTHORIZING THE LEVY OF A ROOM OCCUPANCY AND TOURISM DEVELOPMENT TAX, AND TO AMEND THE ROOM OCCUPANCY AND TOURISM DEVELOPMENT TAXES FOR THE COUNTIES OF CHOWAN AND MARTIN.* As title indicates, extends authority to levy occupancy tax to Town of Ahoskie (3%), a newly created Ocracoke Township Taxing District (2% in addition to any existing local occupancy tax), Chowan County (2% in addition to previously authorized 3% tax), and Martin County (3% in addition to previously authorized 3% tax). Generally conforms tax collection, administration, penalties and permitted uses for Chowan and Martin counties to provisions in 2nd edition for Elkin, Pilot Mountain, and Dobson. Makes conforming changes to GS 160A-215(g) and GS 153A-155(g).

H 2259. ELKIN/PILOT MTN/DOBSON OCCUPANCY TAX (NEW). Filed 5/18/06. Senate committee substitute makes the following changes to 3rd edition. Makes new title *AN ACT TO AUTHORIZE THE TOWNS OF ELKIN, PILOT MOUNTAIN, AND DOBSON TO LEVY A SIX PERCENT ROOM OCCUPANCY AND TOURISM DEVELOPMENT TAX.* Deletes provisions in Parts IV-VII, which authorized occupancy and tourism taxes for Ahoskie, Ocracoke, Chowan, and Martin. Makes conforming changes to GS 160A-215(g) and 153A-155(g).
