**H 2273. LAW ENFORCEMENT USE OF ATVS.** Filed 5/18/06. *TO PERMIT LAW ENFORCEMENT OFFICERS AND FIRST RESPONDERS TO USE ALL-TERRAIN VEHICLES ON PUBLIC STREETS AND HIGHWAYS IN CURRITUCK COUNTY.* As title indicates.

Authorization applies to vehicles owned or leased by the government agency.

**H 2273. LAW ENFORCEMENT USE OF ATVS.** Filed 5/18/06. House committee substitute makes the following changes to 1st edition. Deletes amendment to GS 20-114.2 and instead amends Section 3 of SL 2004-108, as amended, to authorize both law enforcement and municipal employees in Currituck County to use all-terrain vehicles on public streets and highways in Currituck County. Defines "municipal employee" to include the employees of a county for purposes of SL 2004-108, affecting, in addition to Currituck County, the cities of Albemarle and Kings Mountain and the towns of Beaufort, Southern Shores, Kill Devil Hills, Kitty Hawk, and Nags Head.

**H 2273. LAW ENFORCEMENT USE OF ATVS.** Filed 5/18/06. Senate committee substitute makes the following changes to 2nd edition. Adds the towns of Cramerton and Dallas to the jurisdictions in which law enforcement officers and municipal and county employees may use all-terrain vehicles on public streets and highways, and adds the Town of Highlands to the jurisdictions in which law enforcement officers alone may do so.
