H 288. MV MOVE-OVER LAW CHANGES. TO AMEND THE LAW CONCERNING WHAT THE DRIVER OF A MOTOR VEHICLE SHALL DO UPON THE APPROACH OF AN EMERGENCY VEHICLE. Amends GS 20-157(f) to include public service vehicles, in addition to emergency vehicles, as requiring action under the statute, and requires drivers to be prepared to stop, as well as reduce speed. Establishes the following penalties for violations of the statute: (1) violating the statute and causing the death of a police officer or any other emergency response person in the vicinity of the emergency vehicle—Class F felony, fine of not more than \$10,000, imprisonment, or both, and revocation of drivers license for 2 years; (2) violating the statute and causing injury to a police officer or any other emergency response person in the vicinity of the emergency vehicle—Class H felony, fine of not more than \$5,000, imprisonment, or both, and revocation of drivers license for 2 years; (3) violation of statute and causing damage to property in the vicinity of the emergency vehicle—Class I felony, fine of not more than \$500, or imprisonment, or both, and suspension of drivers license for 180 days; (4) all other violations—Class 1 misdemeanor, fine of not more that \$250, imprisonment for not more than 120 days, or both. H 288. MV MOVE-OVER LAW CHANGES. Intro. 2/17/05. House committee substitute makes the following changes to 1st edition. Amends GS 20-157(f) to define "public service vehicle" and to require drivers passing emergency vehicles to reduce the vehicle's speed by at least 20 miles per hour under a posted speed limit of 25 miles per hour or greater, or to five miles per hour when posted speed limit is 20 miles per hour or less. Establishes the following penalties for violations of the statute: (1) violating the statute and causing serious injury to or the death of a police officer or any other emergency response person in the vicinity of the emergency vehicle—Class I felony and revocation of drivers license for up to six months with possibility of limited driving privileges; (2) violating the statute and causing damage to property in excess of \$500 or injury to a police officer or other emergency response person in the vicinity of the emergency vehicle—Class 1 misdemeanor; (3) all other violations—infraction punishable by a fine of \$250. Changes effective date from December 1, 2005 to July 1, 2006.
