H 350. MARTIN COUNTY OCCUPANCY TAX CHANGES (NEW). Filed 2/22/05. Senate committee substitute makes the following changes to 2nd edition. Makes new title *AN ACT TO AUTHORIZE MARTIN COUNTY TO LEVY AN ADDITIONAL THREE PERCENT ROOM OCCUPANCY AND TOURISM DEVELOPMENT TAX AND MAKE OTHER ADMINISTRATIVE CHANGES*. Amends SL 1991-80 to authorize the Board of County Commissioners to levy an additional room occupancy and tourism development tax of up to 3 percent of the gross receipts from room rentals. Provides that both the existing and additional tax must be levied, administered, collected, and repealed as provided in GS 153A-155 (Uniform provisions for room occupancy taxes). Changes the name of the Martin County Travel and Tourism Authority to the Martin County Tourism Development Authority and deletes the provision allowing the Board to abolish and itself carry out the duties of the Authority. Requires the Authority to use at least two-thirds of its funds to promote travel and tourism (primarily marketing activity) in Martin County and the remainder for other tourism-related expenditures (may include tourism-related capital expenditures). Provides that the Authority receive the gross proceeds of the two taxes minus the cost to the county of administering and collecting the tax (not to exceed 3 percent of the first \$500,000 of gross proceeds and 1% of the remaining gross receipts collected each year). Mandates that at least one-third of the Authority's members must be affiliated with businesses that collect the tax in the county and at least one-half must be currently active in county's travel and tourism promotion. Makes other conforming changes.
