H 447. LEO CREDITABLE SERVICE/WORKERS' COMPENSATION. TO PROVIDE THAT CREDITABLE SERVICE FOR LAW ENFORCEMENT OFFICERS IN THE LOCAL GOVERNMENTAL EMPLOYEES' RETIREMENT SYSTEM SHALL INCLUDE PERIODS OF EMPLOYER-APPROVED LEAVES OF ABSENCE WHEN IN RECEIPT OF WORKERS' COMPENSATION BENEFITS AS A RESULT OF CERTAIN INJURIES INCURRED IN THE LINE OF DUTY. Amends GS 128-26(l) to provide that if a law enforcement officer who is on an employer-approved leave of absence, who is receiving Workers' Compensation benefits as a result of serious bodily injury incurred in the line of duty as a result of an intentional or unlawful act of another, and who returns to service on or after August 1, 2005, elects to purchase creditable service for the time on leave of absence, the employing law enforcement agency must pay the lump sum payable under GS 128-26(l)(2).

Amends GS 128-26(l) to provide that if a law enforcement officer returns from leave for certain work-related injuries on or after August 1, 2006 (was, August 1, 2005), and elects to purchase creditable service for the time on leave, the employing law enforcement agency must pay the lump sum payable under GS 128-26(l)(2). Changes effective date of act from August 1, 2005, to August 1, 2006.
