H 688. CERTIFY ON-SITE WASTEWATER CONTRACTORS (=S 568). *TO PROVIDE FOR THE CERTIFICATION OF ON-SITE WASTEWATER CONTRACTORS AND INSPECTORS.* Identical to S 568, introduced 3/16/05.

H 688. CERTIFY ON-SITE WASTEWATER CONTRACTORS. Intro. 3/17/05. House committee substitute makes the following changes to 1st edition. Modifies proposed GS 90A-71 to replace definition of "inspector" with definition of "certified on-site wastewater system inspector," defined as a person certified under Article 5 of GS Chapter 90A to inspect an on-site wastewater system at the time of resale. Further modifies section to clarify that an "on-site wastewater system" includes only a wastewater system that does not discharge to a treatment facility or the surface waters. Modifies proposed GS 90A-72 to also exempt from the wastewater certification requirements persons certified by the Water Pollution Control System Operators Certification Comm'n and contracted to maintain and operate an on-site wastewater system, persons permitted to construct certain water pollution control facilities, and certain persons licensed as public utilities or plumbing contractors. Modifies proposed GS 90A-76 to require that the On-Site Wastewater Certification Fund be used solely for the costs of administering Article 5. Changes effective date of proposed GS 90A-72, 90A-79, and 90A-82 relating to new wastewater certification requirements to July 1, 2007 (was, January 1, 2007). Makes technical changes.

H 688. CERTIFY ON-SITE WASTEWATER CONTRACTORS. Intro. 3/17/05. House committee substitute makes the following changes to 2nd edition. Limits inspector certification to inspections conducted after a permit is issued by the local health department. Exempts from the certification requirement (1) persons employed by or performing labor for a certified contractor or inspector and acting under direct and personal supervision of the certified contractor or inspector; and (2) license plumbing contractors as long as not performing plumbing work that includes installation or repair of a septic tank or similar depository or lines or appurtenances downstream from where lines from the building meet the septic tank or similar depository. Provides that service on On-Site Wastewater Contractors and Inspectors Certification Board is additional to any other office held by board members. Permits suspension or revocation of certificate for failure to satisfactorily complete continuing education requirements. Modifies terms for initial members of board. Deletes provision permitting new certification board to adopt temporary rules. Deletes provision allowing issuance of certificates to entities.

H 688. CERTIFY ON-SITE WASTEWATER CONTRACTORS. Filed 3/16/05. Senate committee substitute makes the following changes to 3rd edition. Changes the effective date of act from July 1, 2007, to January 1, 2008, for the new statutes requiring certification and continuing education and providing remedies for violations. Amends Section 2.(a) to modify the length of the initial terms served by various members of the NC On-Site Wastewater Contractors and Inspectors Certification Board.

SL 2006-82 (H 688). CERTIFY ON-SITE WASTEWATER CONTRACTORS. AN ACT TO PROVIDE FOR THE CERTIFICATION OF ON-SITE WASTEWATER CONTRACTORS AND INSPECTORS. Summarized in *Daily Bulletin* 3/17/05, 7/7/05, 7/26/05, and 6/1/06. Enacted July 10, 2006. Effective July 10, 2006, except that GS 90A-72, 90A-79, and 90A-81, as enacted by Section 1, are effective January 1, 2008.
