H 749. AGREEMENT FOR TRANSPORTATION IMPROVEMENTS.-AB. TO AUTHORIZE THE BOARD OF TRANSPORTATION TO APPROVE PARTNERSHIP AGREEMENTS TO MAKE NEEDED TRANSPORTATION IMPROVEMENTS. Authorizes tolls and other financing methods as title indicates. Effective July 1, 2005.

H 749. AGREEMENT FOR TRANSPORTATION IMPROVEMENTS. Intro. 3/17/05. House committee substitute makes the following changes to 1st edition. Makes technical changes only.

July 6, 2006

H 749. AGREEMENT FOR TRANSPORTATION IMPROVEMENTS. Filed 3/16/05. House committee substitute makes the following changes to 2nd edition. Modifies proposed GS 143B-350(f) by deleting extraneous language in the first sentence and by deleting the second sentence, which would have required expenditures approved under that subdivision to be included in the most recent Transportation Improvement Program. Changes the effective date from July 1, 2005, to August 1, 2006.

H 749. DOT AGREEMENTS/NO STICKER FEE/LTD. DRIV. PRIV. (NEW). Filed 3/16/05. Senate committee substitute makes the following changes to 3rd edition. Changes title to *AN ACT TO AUTHORIZE THE DEPARTMENT OF TRANSPORTATION TO ENTER INTO CERTAIN HIGHWAY FINANCING AGREEMENTS, TO REQUIRE AGREEMENTS INVOLVING DEPARTMENT FUNDS TO BE APPROVED BY THE BOARD OF TRANSPORTATION, TO PROVIDE THAT REPLACEMENT INSPECTION STICKERS FOR USE ON A REPLACED WINDSHIELD ARE NOT SUBJECT TO THE INSPECTION STICKER FEE, AND TO ALLOW PERSONS WHO ARE CONVICTED OF CERTAIN DRIVING WHILE LICENSE REVOKED OFFENSES TO OBTAIN A LIMITED DRIVING PRIVILEGE*. Amends GS 136-18 by adding new subdivision (39) vesting the Department of Transportation with the power to enter into highway financing agreements with the North Carolina Turnpike Authority, private entities and authorized political subdivisions, subject to the concurrence of the Board of Transportation. Effective date is August 1, 2006. Amends GS 136-89.183(a)(17) by granting the North Carolina Turnpike Authority the power to enter into turnpike financing agreements with the Department of Transportation, private entities, and authorized political subdivisions. Effective date is August 1, 2006. Modifies proposed amendment to GS 143B-350(f) (setting forth the duties and powers of the Board of Transportation) by making stylistic and punctuation changes. Effective date is August 1, 2006. Amends GS 20-183.7(a) to provide that replacement inspection stickers for use on a replaced windshield are not subject to the inspection sticker fee. Effective date is July 1, 2007. Adds new GS 20-20.1 providing for the district court to grant a one-year limited driving privilege to certain persons with revoked driver's licenses. The limited driving privilege is to be granted only for travel to, from, and in the course of employment, necessary maintenance of the person's household, and emergency medical care. Effective date is December 1, 2006, and applies to permanent revocations that occurred before, on, or after that date. Amends GS 7A-305 by adding new subsection (a3) providing for a cost of \$100 to be assessed against each person filing a motion to obtain a limited driving privilege. Effective date is December 1, 2006.

H 749. DOT AGREEMENTS/NO STICKER FEE (NEW). Filed 3/16/05. Conference report recommends the following changes to 4th edition to reconcile matters in controversy. Deletes provisions allowing certain persons with revoked licenses to obtain a limited driving privilege. Makes conforming changes to title.

SL 2006-230 (H 749). DOT AGREEMENTS/NO STICKER FEE. AN ACT TO AUTHORIZE THE DEPARTMENT OF TRANSPORTATION TO ENTER INTO CERTAIN HIGHWAY FINANCING AGREEMENTS, TO REQUIRE AGREEMENTS INVOLVING DEPARTMENT FUNDS TO BE APPROVED BY THE BOARD OF TRANSPORTATION, AND TO PROVIDE THAT REPLACEMENT INSPECTION STICKERS FOR USE ON A REPLACED WINDSHIELD ARE NOT SUBJECT TO THE INSPECTION STICKER FEE. Summarized in *Daily Bulletin* 3/17/05, 6/1/05, 7/6/06, 7/19/06, and 7/27/06. Enacted August 10, 2006. Section 1 is effective August 1, 2006. Section 2 is effective July 1, 2007.
