**H 85. ALPHA PHI ALPHA FRATERNITY SPECIAL PLATE.** *TO AUTHORIZE THE DIVISION OF MOTOR VEHICLES TO ISSUE AN ALPHA PHI ALPHA SPECIAL REGISTRATION PLATE.* Adds new GS 20-79.4(b)(1d) as title indicates, plate issuance contingent upon 300 applications. One-half of proceeds to be transferred to Ass'n of NC Alphamen (ANCA) Educational Foundation for scholarships for African-American males in ANCA attending accredited NC colleges.

**H 85. VARIOUS SPECIAL LICENSE PLATES (NEW).** Intro. 2/7/05. House committee substitute deletes all provisions of 1st edition and replaces them with *AN ACT TO AUTHORIZE THE DIVISION OF MOTOR VEHICLES TO ISSUE THE FOLLOWING SPECIAL REGISTRATION PLATES: AIR MEDAL RECIPIENT, ALPHA PHI ALPHA FRATERNITY, ARC OF NORTH CAROLINA, AUTISM SOCIETY OF NORTH CAROLINA, BUDDY PELLETIER SURFING FOUNDATION, COASTAL CONSERVATION ASSOCIATION, COLD WAR VETERAN, CORVETTE CLUB, GUILFORD BATTLEGROUND COMPANY, NATIONAL MULTIPLE SCLEROSIS SOCIETY, NATIONAL WILD TURKEY FEDERATION, NORTH CAROLINA AQUARIUM, NORTH CAROLINA MUSEUM OF NATURAL SCIENCES, OPERATION ENDURING FREEDOM, OPERATION IRAQI FREEDOM, SCUBA, SHARE THE ROAD, AND TARHEEL CLASSIC THUNDERBIRD CLUB.* Amends GS 20-79.4(b) as title indicates. With the exception of the Air Medal Recipient plate, requires receipt of at least 300 applications prior to the issuance of each plate and exempts the Surfing Foundation, Battleground Company, Wild Turkey Federation, and Aquarium Society plates from the "First in Flight" graphic requirement. In addition to the regular motor vehicle registration fee set forth in GS 20-87 or 20-88, imposes an additional fee for each plate ranging from \$10 to \$30 and, with the exception of the Air Medal Recipient, Cold War Veteran, Corvette Club, Operation Iraqi Freedom, and Tarheel Classic Thunderbird Club plates, requires that a portion of that fee be used to support activities of the organizations listed. Amends GS 20-79.4(a) to prohibit the use of a trademark on a special registration plate unless the holder of the trademark licenses the State to use its trademark on plate. Makes confirming changes to GS 20-79.4(b).

**H 85. VARIOUS SPECIAL LICENSE PLATES.** Intro. 2/7/05. House amendment makes the following changes to 2nd edition. Makes technical changes only.

**H 85. VARIOUS SPECIAL LICENSE PLATES.** Intro. 2/7/05. Senate committee substitute makes the following changes to 3rd edition. Amends GS 20-79.4(b) to authorize the issuance of the Marine Corps League, NC Libraries, NC Wildlife Habitat Foundation, and Shag Dancing plates; requires receipt of at least 300 applications prior to the issuance of each plate. In addition to the regular motor vehicle registration fee set forth in GS 20-87 or 20-88, imposes an additional fee for the NC Libraries plate of \$30, the NC Wildlife Habitat Foundation plate of \$20, and the Shag Dancing plate of \$15 and requires that a portion of each fee be used to support activities of the organizations listed. Amends GS 20-63(b) to exempt the First in Forestry and the NC Wildlife Habitat Foundation plates from the "First in Flight" plate graphic requirements.

**H 85. VARIOUS SPECIAL LICENSE PLATES.** Intro. 2/7/05. Senate amendments make the following changes to 4th edition. Amendment #1 amends GS 20-79.4(b) to authorize the issuance of the NC Trout Unlimited license plate and Amendment #2 authorizes the issuance of the Watermelon license plate; amendments require receipt of at least 300 applications prior to the issuance of each plate. Amendment #1 also imposes an additional fee of \$20 and requires that a

portion of fee be used to support the activities of NC Trout Unlimited and amends GS 20-63(b) to exempt the NC Trout Unlimited plate from the "First in Flight" graphic requirement.
