Filed 5/9/06. *ALLOWING LOCAL DEPARTMENTS OF SOCIAL SERVICES TO SHARE CONFIDENTIAL INFORMATION WITH OTHER CHILD PROTECTION ORGANIZATIONS WHEN THE CONFIDENTIAL INFORMATION IS NEEDED TO PROTECT A CHILD FROM ABUSE AND NEGLECT.* Rewrites GS 7B-302(a) to require county social services departments to disclose confidential information to any federal, state, or local government entity or its agent that needs the information to protect a juvenile from abuse and neglect.

S 1216. DSS DISCLOSURE OF INFORMATION/ABUSE/NEGLECT. Filed 5/9/06. Senate committee substitute makes the following changes to 1st edition. Amends GS 7B-302(a) to provide that confidential information disclosed to other government entities must remain confidential.

S 1216. DSS DISCLOSURE OF INFORMATION/ABUSE/NEGLECT. Filed 5/9/06. Senate amendment makes the following changes to 2nd edition. Amends GS 7B-302(a) to prohibit the redisclosure of any confidential information disclosed by a local department of social services to other governmental entities unless the purpose of the redisclosure is directly related to the governmental entity's mandated responsibilities.

S 1216. DSS DISCLOSURE OF INFORMATION/ABUSE/NEGLECT. Filed 5/9/06. House committee substitute makes the following changes to 3rd edition. Amends GS 7B-3100(a) to require designated agencies to share information that is relevant to a county social services department's (1) assessment of a child abuse, neglect, or dependency report or (2) provision of or arrangement for child protective services. Rewrites title accordingly.

S 1216. DSS DISCLOSURE OF INFORMATION/ABUSE/NEGLECT. Filed 5/09/06. Conference report recommends the following changes to 4th edition to reconcile matters in controversy. Modifies amendment to GS 7B-3100(a) by clarifying that local agencies authorized to share information concerning juveniles may do so only to the extent permitted by federal law and regulations.
