S 1584. UNDERGROUND STORAGE TANK PRGM. FUNDS. Filed 5/17/06. *TO APPROPRIATE FUNDS TO THE COMMERCIAL LEAKING PETROLEUM UNDERGROUND STORAGE TANK CLEANUP FUND TO EXPEDITE THE ASSESSMENT AND CLEANUP OF DISCHARGES AND RELEASES FROM PETROLEUM UNDERGROUND STORAGE TANKS AND TO FACILITATE THE TRANSITION TO RELIANCE ON PRIVATE INSURANCE, AND TO APPROPRIATE FUNDS TO THE DEPARTMENT OF ENVIRONMENT AND NATURAL RESOURCES TO COVER INCREASED PROGRAM OPERATING COSTS AND THE COSTS OF ANY LEGISLATIVE SALARY INCREASE FOR PERSONNEL WHO ADMINISTER THE PROGRAM, AS RECOMMENDED BY THE ENVIRONMENTAL REVIEW COMMISSION.* Appropriates \$15 million for 2006-07 from General Fund to Commercial Leaking Petroleum Underground Storage Tank Cleanup Fund as title indicates; states that it is intent of the General Assembly that this appropriation be a continuing appropriation through 2016-17. Appropriates \$100,000 for 2006-07 from Commercial Leaking Petroleum Underground Storage Tank Cleanup Fund to Department of Environment and Natural Resources as title indicates. Appropriates \$100,000 for 2006-07 from Noncommercial Leaking Petroleum Underground Storage Tank Cleanup Fund to Department of Environment and Natural Resources as title indicates. States that it is the intent of the General that funds appropriated by this act are recurring funds that are in addition to funds appropriated under subsection 11.4(b) of SL 2003-284 and subsection 30.10(b) of SL 2004-124. Effective July 1, 2006.

S 1584. UNDERGROUND STORAGE TANK PRGM. ADM. FUNDS (NEW). Filed 5/17/06. Senate committee substitute makes the following changes to 1st edition. Deletes \$15 million appropriation from the General Fund to the Commercial Leaking Petroleum Underground Storage Tank Cleanup Fund for 2006-07. Also decreases both appropriations from the Noncommercial and Commercial Leaking Petroleum Underground Storage Tank Cleanup Funds to the Department of Environment and Natural Resources from \$100,000 to \$82,700. Conforms title.

S 1584. UNDERGROUND STORAGE TANK PRGM. ADM. FUNDS. Filed 5/17/06. Senate committee substitute makes the following changes to 2nd edition. Increases the 2006-07 appropriations from the Commercial Leaking Petroleum Underground Storage Tank Cleanup Fund to the Department of Environment and Natural Resources (DENR), and the Noncommercial Leaking Petroleum Underground Storage Tank Cleanup Fund to DENR, from \$82,700 to \$137,106.
