Enacts new GS 143-215.3D(e)(8) to require that the Environmental Management Commission establish a nutrient offset payment using a per pound factor of \$35 per pound of nitrogen and per tenth of a pound of phosphorous. Effective July 1, 2006, and applies to nutrient offset payments as adopted by the Commission on January 12, 2006.

S 1862. LIMIT NUTRIENT OFFSET PAYMENTS. Filed 5/24/06. Senate committee substitute makes the following changes to 1st edition. (1) Changes title to AN ACT TO SET THE PER POUND FACTOR USED BY THE ENVIRONMENTAL MANAGEMENT COMMISSION TO CALCULATE NUTRIENT OFFSET PAYMENTS AND TO DIRECT THE ENVIRONMENTAL REVIEW COMMISSION TO STUDY ISSUES RELATED TO THE NUTRIENT OFFSET PAYMENTS. (2) Continues the preemption of existing Environmental Management Commission rules governing nutrient offset payment amounts, proposed by original bill, but removes the proposed codification in GS 143-215.3D(e) and changes the charges for nitrogen and phosphorus as follows: (a) \$11 per pound of nitrogen (original bill, \$35 per pound) and (b) \$45 per tenth of a pound of phosphorus (original bill, \$35 per tenth of a pound of phosphorus. (3) Directs the Environmental Review Commission to study issues related to nutrient offset payments with the assistance of the Division of Water Quality of the Department of Environment and Natural Resources (DENR). Directs that the study determine the costs associated with providing nutrient controls adequate to offset nitrogen discharges, whether payments should be authorized for additional nutrients, including phosphorus, and whether program should be expanded to other areas of state. Directs the commission to report findings and recommended legislation to the 2007 General Assembly, upon its convening. (4) Directs the Division of Water Quality of the DENR to refund any fees paid in excess of the amounts established in the act. (5) Changes the effective date from July 1, 2006, to August 1, 2006, and provides that the act expires September 1, 2007.

Deletes the provisions setting the per pound factor for phosphorus and provides that there will be no nutrient offset program pursuant to a rule adopted by the Environmental Management Commission. Conforms title.

S 1862. LIMIT NUTRIENT OFFSET PAYMENTS. Filed 5/24/06. Conference report recommends the following changes to 3rd edition to reconcile matters in controversy. Reinstates phosphorus offset payments, but reduces amount to \$11 per tenth of a pound of phosphorus. Retains nitrogen offset payments at \$11 per pound. Conforms title.
