Filed 5/24/06. *AUTHORIZING THE TOWN OF CLAYTON TO LIMIT THE CLEAR-CUTTING OF TREES IN BUFFER ZONES PRIOR TO DEVELOPMENT.* Permits the Town of Clayton to adopt ordinances as title indicates. Establishes requirements for such ordinances, including holding a public hearing before adopting any ordinance.

S 1928. CLAYTON/CLEAR-CUTTING TREES. Filed 5/24/06. Senate amendment makes the following changes to 1st edition. Adds "agricultural" and "horticultural" land to the types of property taxed on the basis of present-use that must be excluded from Clayton's buffer zone prohibitions on clear-cutting if the forestry activities on the land are part of an approved management plan and comply with other requirements.

S 1928. CLAYTON/REIDSVILLE CLEAR-CUT/CLAYTON ANNEX (NEW). Filed 5/24/06. House committee substitute makes the following changes to 2nd edition. Extends authority to adopt tree buffer ordinance to the City of Reidsville. Adds sections authorizing the Town of Clayton to annex defined territory along NC Highway 50 in Cleveland Township by petition for annexation. Conforms title to: *AN ACT AUTHORIZING THE TOWN OF CLAYTON AND THE CITY OF REIDSVILLE TO LIMIT THE CLEAR-CUTTING OF TREES IN BUFFER ZONES PRIOR TO DEVELOPMENT, AND TO ALLOW ANNEXATION OF CERTAIN DESCRIBED PROPERTY IN JOHNSTON COUNTY TO THE CORPORATE LIMITS OF THE TOWN OF CLAYTON.*
