S 489. COSMETIC ART DEFINITIONS/EXAM FACILITIES. AUTHORIZING THE NORTH CAROLINA BOARD OF COSMETIC ART EXAMINERS TO CLARIFY CERTAIN DEFINITIONS UNDER THE NORTH CAROLINA COSMETIC ART ACT, TO APPROVE EXAMINATION FACILITIES, AND TO SET LIMITS FOR FAILED CANDIDATES SEEKING TO RETAKE AN EXAMINATION. Modifies definition of “cosmetic art” and adds definitions of “cosmetology” and “esthetics” to GS Chapter 88B. Authorizes NC Board of Cosmetic Art Examiners to administer examinations in any facility approved by Board (was, required that examinations be held in Board’s office or at public two-year postsecondary educational institutions). Provides that applicants for an esthetician, manicurist, or teacher’s license who fail licensing examination three times must satisfy additional requirements set by Board before retaking examination. Makes technical change.

S 489. COSMETIC ART DEFINITIONS/EXAM FACILITIES. Intro. 3/15/05. Senate committee substitute makes the following changes to 1st edition. Amends GS 88B-3 to increase from six to seven the number of members of the North Carolina Board of Cosmetic Art Examiners, adding a cosmetology teacher currently employed by a North Carolina community college to the Board.

S 489. COSMETIC ART DEFINITIONS/EXAM FACILITIES. Filed 3/10/2005. House committee substitute makes the following changes to 2nd edition. Amends GS 88B-22 to make it a Class 3 misdemeanor for teachers to teach cosmetic arts without a teaching license and deleting language regarding estheticians and manicurists. Conforms title.

S 489. COSMETIC ART DEFINITION/EXAM FACILITIES. Filed 3/10/05. House amendment makes the following change to 3rd edition. Amends GS 88B-21(e) to provide an exception to the continuing education requirements for a licensed cosmetologist who has at least 20 consecutive years of experience as a cosmetologist.

July 24, 2006

S 489. COSMETIC ART DEFINITIONS/EXAM FACILITIES. Filed 3/10/2005. Conference report recommends the following changes to 4th edition to reconcile matters in controversy. Deletes changes to GS 88B-3 (Creation and membership of Board, etc.). Modifies definitions of cosmetic art and esthetics in GS 88B-2. Deletes requirement in GS 88B-18 (Examinations) that applicants for examinations file an application with the Board at least 30 days before the examination date and pay an examination fee. Reinstates deleted provision in GS 88B-22 (Licenses required; criminal penalty) providing that an individual licensed as an esthetician or manicurist may practice only that part of cosmetic art for which the person is licensed. Amends GS 88B-11 pertaining to qualifications for licensing teachers.

AN ACT TO AUTHORIZE THE NORTH CAROLINA BOARD OF COSMETIC ART EXAMINERS TO CLARIFY CERTAIN DEFINITIONS UNDER THE NORTH CAROLINA COSMETIC ART ACT, TO APPROVE EXAMINATION FACILITIES, AND TO SET LIMITS FOR FAILED CANDIDATES SEEKING TO RETAKE AN EXAMINATION, AND TO AMEND CERTAIN LICENSURE REQUIREMENTS UNDER THE NORTH CAROLINA COSMETIC ART ACT.
