S 491. BUTNER WATER/SEWER TRANSF/PUB SAFETY (NEW). Filed 3/10/05. House committee substitute deletes all provisions of 3rd edition and replaces it with AN ACT TO TRANSFER THE ASSETS OF THE BUTNER WATER AND SEWER AUTHORITY, AND TO PROVIDE THAT BUTNER PUBLIC SAFETY SHALL BE CONSIDERED THE EQUIVALENT OF A MUNICIPAL POLICE DEPARTMENT FOR PURPOSES OF THE LAWS PROVIDING FOR COOPERATION BETWEEN LAW ENFORCEMENT AGENCIES AND ASSISTANCE TO STATE LAW ENFORCEMENT AGENCIES. Requires the transfer of the assets of the Butner Water and Sewer Authority to the South Granville Water and Sewer Authority ("SGWASA") or before January 1, 2007. Also requires that the Department of Health and Human Services (DHHS) transfer \$2,069,432.50 from the funds held by DHHS for the Town of Butner Enterprise in the State General Ledger System (ATBD 701) to SGWASA, an amount equal to half of a year's operating expenses of the water and sewer system. Provides that if a majority of the functions of the Butner Reservation are assumed by a municipal corporation, the remainder of the funds held in the ATBD 701 and all Capital Improvement Funds will be transferred by DHHS to the successor municipality. Provides for the payment of a monthly amount by SGWASA to DHHS until the functions performed by DHHS at the Butner Reservation are assumed by a municipal corporation, and specifies an amount to be paid by SGWASA to the municipal corporation thereafter. States that the transfer of the system is exempt from the requirements of Article 7 of GS Chapter 146 (requiring approval of land conveyances by the Governor and the Council of State). Amends GS 160A-288 (cooperation between law-enforcement agencies) and GS 160A-288.2 (assistance to State law-enforcement agencies) to add Butner Public Safety to the list of law enforcement agencies that are considered the equivalent of a municipal police department.
