**S 644. EXEMPT BANKING COMM. STAFF FROM SPA.** *EXEMPTING THE EMPLOYEES OF THE STATE BANKING COMMISSION FROM COVERAGE UNDER THE STATE PERSONNEL ACT.* Amends GS 126-5(c1) as title indicates. Effective July 1, 2005.

**S 644. EXEMPT BANKING COMM. STAFF FROM SPA.** Intro. 3/17/05. Senate amendment makes the following changes to 1st edition. Changes title to *AN ACT EXEMPTING THE EMPLOYEES OF THE STATE BANKING COMMISSION FROM COVERAGE UNDER THE COMPENSATION PROVISIONS OF THE STATE PERSONNEL ACT.* Adds new GS 53-96.1 exempting employees of the Office of the Commissioner of Banks from Article 2 of Chapter 126 of the General Statutes and codifies purpose of exemption. Deletes provision that would have added new subdivision (23) to GS 126-5(c1) to exempt banking commission employees from the State Personnel Act.

**S 644. EXEMPT BANKING COMM. STAFF FROM SPA.** Intro. 3/17/05. House committee substitute makes the following changes to 2nd edition. Modifies proposed GS 53-96.1 to make the Office of the Comm'r of Banks and its employees exempt from certain classification and compensation rules established by the State Personnel Comm'n under specified subsections of GS 126-4. Makes technical and conforming changes to GS 53-101. Changes effective date from July 1, 2005, to date on which act becomes law.

**S 644. EXEMPT BANKING COMM. STAFF FROM SPA.** Intro. 3/17/05. House committee substitute makes the following changes to 3rd edition. Modifies proposed GS 53-96.1 to specify that the Office of the Comm'r of Banks and its employees will be subject to the provisions of GS 126-7.1 (job posting, priority consideration, and reduction-in-force rights). Requires that the Comm'r develop organizational classification and compensation innovations (was, compensation only) and implement human resource programs and an organizational structure that include job descriptions, time off policies, and uniform performance assessments.

**SL 2005-284 (S 644). EXEMPT BANKING COMMISSION STAFF FROM SPA.** *AN ACT EXEMPTING THE EMPLOYEES OF THE STATE BANKING COMMISSION FROM COVERAGE UNDER CERTAIN CLASSIFICATION AND COMPENSATION RELATED PROVISIONS OF THE STATE PERSONNEL ACT.* Summarized in *Daily Bulletin* 3/17/05, 4/27/05, 7/6/05, and 7/28/05.
