S 778. AMEND PRIVATE PROTECTIVE SERVICES LAWS. TO AMEND CERTAIN LAWS REGULATING LICENSURE FOR PRIVATE PROTECTIVE SERVICES. Amends GS 74C-11(f) to require that licensees employing temporary unarmed security guards report on that employee's completion of required training on a quarterly basis.

S 778. AMEND PRIVATE PROTECTIVE SERVICES LAWS. Intro. 3/22/05. Senate committee substitute makes the following changes to 1st edition. Changes title to *AN ACT AMENDING CERTAIN LAWS REGULATING PERSONS ENGAGED IN PROVIDING PRIVATE PROTECTIVE SERVICES TO ALLOW FOR PROBATIONARY EMPLOYEES AND THE REGISTRATION OF REGULAR EMPLOYEES*. Reorganizes GS 74C-11 by (1) deleting subsection (f) authorizing a licensee to employ unregistered, unarmed security guards for up to 30 days each year if the licensee files a quarterly report; and (2) authorizing a licensee to employ unarmed security guards as probationary employees for 20 days if the licensee files a monthly report. Further requires licensee to register employee within 30 days after probationary period ends if licensee wishes to hire employee as regular employee. Requires probationary employees to complete training requirements and licensees to conduct criminal record checks, as required by the Board, before probationary employees engage in private protective services.

S 778. AMEND PRIVATE PROTECTIVE SERVICES LAWS. Intro. 3/22/05. House committee substitute makes the following changes to 2nd edition. Amends GS 14-415.12A to provide that a person licensed by the NC Private Protective Services Board as an armed security guard who also has an armed security guard firearm registration permit is considered to have satisfied the approved firearms safety and training course requirement for a concealed handgun permit, effective for permit applications submitted on or after date act becomes law. Makes technical change.
