S 98. ORANGE COUNTY SUPER PRECINCT. *TO AUTHORIZE THE ORANGE COUNTY BOARD OF ELECTIONS TO CONDUCT A PILOT PROGRAM IN WHICH THE METHODS USED IN ONE-STOP VOTING WOULD CONTINUE THROUGH ELECTION DAY AS THE VOTING METHOD, TO BE KNOWN AS "SUPER PRECINCTS" OR "VOTE CENTERS."* As title indicates, pilot program to be for any elections occurring prior to Jan. 1, 2007. No polling places are to be open on election day other than one-stop sites, and all such sites shall have a real-time online connection to the voter registration system so that voters can be checked. Notwithstanding GS 163-227.2(g), the State Board of Elections may allow the county board of elections to designate one-stop sites in commercial buildings. State Board is to monitor the pilot program and report its findings to the General Assembly at its 2006 Regular Session and to the 2007 General Assembly.

S 98. ORANGE COUNTY SUPER PRECINCT. Intro. 2/10/05. Senate committee substitute makes the following changes to 1st edition. Clarifies that provisional ballots cast under one-stop method must continue to be marked with individualized voter identification.

S 98. ORANGE COUNTY SUPER PRECINCT. Intro. 2/10/05. Senate amendment makes the following changes to 2nd edition. Clarifies that voting will take place as provided in current one-stop program as well as on election day, rather than on every day prior to and including election day.

S 98. ORANGE COUNTY VOTING CENTERS (NEW). Intro. 2/10/05. House committee substitute makes the following changes to 3rd edition. Provides that the pilot program will be in Chapel Hill Township, that that the section's requirements prevail over other requirements as to voting at one-stop sites, and that voting places, whether during the one-stop period or on election day, will be known as voting centers. Modifies required pilot program elements and adds new program elements. Makes technical changes.
