**H 1227. NEW HANOVER REGIONAL MEDICAL CTR/CONTRACTS.** Filed 3/28/07. *EXEMPT NEW HANOVER REGIONAL MEDICAL CENTER, A NEW HANOVER COUNTY OWNED HOSPITAL, FROM STATUTORY REQUIREMENTS GOVERNING PUBLIC CONTRACTS.*

Provides that the New Hanover Regional Medical Center (center) is exempt from provisions concerning the acquisition, operation, or disposition of property by other public bodies, but sets several requirements for the center including receiving at least three bids before awarding a contract or allowing the disposition of property. States the General Assembly's intent to provide full public inspection, disclosure, and review of contracts awarded and requires the center to make any public records relevant to awarded contracts available to the public. Expires June 30, 2010.

**H 1227. NEW HANOVER REGIONAL MEDICAL CTR/CONTRACTS.** Filed 3/28/07. House committee substitute makes the following changes to 1st edition. Modifies the exceptions to the exemptions from statutory requirements governing public contracts provided to New Hanover Regional Medical Center (Center) under the act by eliminating the following requirements: (1) that the Center obtain a resolution from the Center's Board of Trustees requesting approval of the Center's statutory exemptions from the New Hanover County Commissioners; (2) that the Center receive at least three competitive bids before awarding contracts or the disposition of property; and (3) that the Center make public any contracts awarded under the act immediately. Directs that the Center use the authority granting the statutory exemption only when it is in the best interest of the Center to do so and that it provide in writing specific reasons why it used the authority. Directs that the Center comply with the provisions of GS Chapter 132 (regarding public records) and GS 131E-97.3 (regarding confidentiality of health care information) in exercising its authority under the act. Removes provision that this act expire as of June 30, 2010.

**H 1227. NEW HANOVER REGIONAL MEDICAL CTR/CONTRACTS.** Filed 3/28/07. House committee substitute makes the following changes to 2nd edition. Deletes provisions regarding withdrawal of approval and when the medical center will use the authority granted in the bill. Revises reporting and recordkeeping requirements and clarifies the public records requirement. Requires the medical center to prepare a document stating why it is using the authority granted in the act once it enters into a contract, and requires the document to be available to the public.
