H 1230. SCENIC BYWAYS BED AND BREAKFAST INNS. Filed 3/28/07. *TO CREATE AN ALCOHOLIC BEVERAGE CONTROL ESTABLISHMENT TYPE CALLED "SCENIC BYWAYS BED AND BREAKFAST INNS" AND TO ALLOW THE ISSUANCE OF CERTAIN ALCOHOLIC BEVERAGE CONTROL PERMITS TO A SCENIC BYWAYS BED AND BREAKFAST INN WITHOUT THE APPROVAL OF AN ELECTION.*

Amends GS 18B-603(f) to allow permits to be issued without approval at an election for malt beverages, unfortified wine, fortified wine, and mixed beverages for scenic byways bed and breakfast inns, defined in new GS 18B-101(14c) as a business with no more than 12 guest rooms offering lodging for at least nine, but no more than 23 persons that is located in a county with three or more designated scenic byways and that meets six other specific conditions relating to a restaurant, catering, the owner's residence, and other ABC permits issued within the county.

H 1230. SCENIC BYWAYS BED AND BREAKFAST INNS. Filed 3/28/07. House committee substitute makes the following changes to 1st edition. Changes proposed conditions that must be met by a scenic byways bed and breakfast inn to require it (1) to operate a kitchen using commercial restaurant equipment, meet restaurant food and beverage requirements, and feature a dining area with a seating capacity of 23 or more (previously required a restaurant with a seating capacity of 32 or more); (2) to be located in a county where the on-premises sale of malt beverages and unfortified wine is authorized in at least two municipalities (was, in at least one city); and (3) to be located in a county where 100 or more businesses have active alcohol beverage permits (was, a county where 100 or more active alcohol beverage permits have been issued).

H 1230. NONPROFIT ABC LAW CHANGES (NEW). Filed 3/28/07. House committee substitute makes the following changes to 2nd edition. Deletes the provisions of the 2nd edition and replaces it with *AN ACT TO AMEND THE LAW CONCERNING THE ISSUANCE OF SPECIAL ONE-TIME PERMITS TO NONPROFIT ORGANIZATIONS.* Amends GS 18B-1002(a)(2) to expand the types of alcoholic beverages for which a permit may be issued to a nonprofit organization for a single fund-raising event to include mixed beverages.

H 1230. NONPROFIT & TOURISM ABC LAW CHANGES (NEW). Filed 3/28/07. Senate committee substitute makes the following changes to 3rd edition. Amends GS 18B-101(14a) to amend the property requirement that must be met by a restaurant or hotel to meet the definition of *tourism ABC establishment* to require that the restaurant or hotel be located on property, a property line of which is located within 2.5 (was, 1.5) miles of the end of an entrance or exit ramp of a junction on a national scenic parkway designed to attract tourists between the state line and milepost 460. Makes a conforming change to the title.

H 1230. NONPROFIT ABC LAW CHANGES. Filed 3/28/07. Conference report recommends the following changes to 4th edition to reconcile matters in controversy. Recedes from the 4th edition.
