**H 1287. REPORT DENIAL OF SOME PISTOL PERMITS.** Filed 4/2/07. *TO PROVIDE THAT DENIAL OF A LICENSE OR PERMIT TO PURCHASE A PISTOL SHALL BE REPORTED TO THE STATE BUREAU OF INVESTIGATION BY ENTRY INTO AN APPROPRIATE COMPUTERIZED DATABASE THAT IS ACCESSIBLE TO SHERIFFS STATEWIDE.*

Enacts new GS 14-404.1 as title indicates. Specifies information to be included in the computerized database and requires that notation of the denial be available in any subsequent record check regarding an application for a license or permit to purchase a pistol. Provides that an individual filing a successful appeal of a denial of a permit or license may make a written request to the sheriff that the notation regarding the previous denial of the individual's application for a permit or license be removed from the computerized database. Directs the State Bureau of Investigation (SBI) to remove the notation within five business days after receiving the request to do so from the sheriff. Directs the SBI to identify, by September 1, 2007, an appropriate state computerized database that is easily accessible to sheriffs statewide and to take any other steps to implement the provisions of this act. The requirement to report denial of a license or permit to the SBI by entering the information into a statewide computerized database is effective September 1, 2008.

**H 1287. REPORT DENIAL OF SOME PISTOL PERMITS.** Filed 4/2/07. House committee substitute makes the following changes to 1st edition. Modifies proposed GS 14-404.1(b) to allow a sheriff who has denied an applicant's permit request and entered the information into the database to later request that the State Bureau of Investigation (SBI) remove the denial from the database if the same officer subsequently issues a permit to the same applicant. Also requires the SBI to remove the denial notation from the database within five days after receiving the sheriff's removal request.

**H 1287. REPORT DENIAL OF SOME PISTOL PERMITS.** Filed 4/2/07. House amendments make the following changes to 2nd edition. Amendment #2 modifies proposed GS 14-404.1, requiring that the sheriff's report to the State Bureau of Investigation (SBI) of the denial of a license or permit to purchase a pistol include the reasons for the denial. Amendment #1 requires that if the sheriff who declined to issue a permit and filed a report with the SBI later issues a permit to the same person, the sheriff must notify the SBI and request that the record of the denial be removed from the SBI database (was, sheriff may notify SBI).

Provides that information entered into the database pursuant to a sheriff declining to issue a permit is accessible only for conducting record checks, except for when the Department of Justice conducts periodic analysis regarding the issuing process of permits under GS 14-404(b).
