H 1471. CHARTER SCHOOL EMPLOYMENT BENEFITS ELECTION. Filed 4/12/07. *TO AUTHORIZE AN EXISTING CHARTER SCHOOL TO ELECT TO PARTICIPATE IN THE TEACHERS' AND STATE EMPLOYEES' RETIREMENT SYSTEM AND THE NORTH CAROLINA TEACHERS' AND STATE EMPLOYEES' MAJOR MEDICAL PLAN.*

Allows the board of directors of Orange Charter School, an existing charter school, to elect to become a participating employing unit in the NC Teachers' and State Employees' Retirement System and Comprehensive Major Medical Plan no later than 30 days after the act becomes law and in accordance with all other requirements of GS 135-40.3A (regarding participation in the retirement system) and GS 135-5.3 (regarding participation in the major medical plan). (Makes an exception to the time limitations in GS 135-40.3A and GS 135-5.3 requiring that a charter school make the election to participate in the retirement system and major medical plan within 30 days of signing its charter.)
