H 1488. AMEND PSYCHOLOGY PRACTICE ACT. Filed 4/16/07. AMENDING THE PSYCHOLOGY PRACTICE ACT TO CLARIFY REQUIREMENTS FOR PERMANENT LICENSURE.

Amends GS 90-270.4(g) to provide that even if a licensed person is not required to be licensed and is not holding themselves out to the public as a psychologist, a licensed psychological associate, or licensed to practice psychology, the person is required to comply with the NC Psychology Board's conditions and requirements. Amends GS 90-270.6 to remove the requirement that each member of the board reside in a different congressional district when appointed, and instead require that consideration be given to adequate representation from the state's various regions when appointing members to the board. Enacts new GS 90-270.13(a1) requiring the board to grant permanent licensure to applicants who have paid the required fees and meet specified requirements, including possessing a doctoral degree in psychology and passing an exam. Also allows the board to deny permanent licensure to an applicant not exhibiting behavior conforming with the requirements of GS 90-270.15(a) (ethical and professional standards). Makes technical and conforming changes.
