H 15. TXTBKS & ASSIGNMTS ON SHORT-TERM SUSPENSION. Filed 1/25/07. TO IMPLEMENT A RECOMMENDATION OF THE HOUSE SELECT COMMITTEE ON THE EDUCATION OF STUDENTS WITH DISABILITIES TO ALLOW STUDENTS PLACED ON SHORT-TERM SUSPENSIONS TO TAKE THEIR TEXTBOOKS HOME FOR THE DURATION OF THE SHORT-TERM SUSPENSION AND TO HAVE ACCESS TO HOMEWORK ASSIGNMENTS. Rewrites GS 115C-391(b) to specify that students receiving short-term suspensions (ten days or less) have (1) the opportunity to take their textbooks home for the suspension period and (2) the right to ask about homework assignments during the suspension period. Maintains current law giving short-term-suspended students the opportunity to take any quarterly, semester, or grading period exams missed during the suspension.

H 15. SOME PERSONAL LEAVE TIME/ NO PENALTY (NEW). Filed 1/25/07. Senate committee substitute deletes all provisions of the 1st edition and replaces it with AN ACT TO PROVIDE THAT TEACHERS ARE NOT PENALIZED FOR TAKING PERSONAL LEAVE TIME UNDER CERTAIN CIRCUMSTANCES.

Current law provides that the salary of a teacher electing to use personal leave is decreased by the required substitute deduction. Amends GS 115C-302.1(d) to provide that teachers using personal leave on non-protected teacher workdays are to receive their full salary with no substitute deduction. Non-protected teacher workdays are days when students are not attending school and no substitute is needed.

H 15. SOME PERSONAL LEAVE TIME/ NO PENALTY. Filed 1/25/07. Conference report recommends the following changes to 2nd edition to reconcile matters in controversy.

Adopts amended GS 115C-302.19(d) as it appears in the second edition but adds the following:

- (1) Provides that subsection (a) of Section 1 of the proposed conference committee substitute (permitting teachers using personal leave on non-protected workdays to receive full salary) becomes effective July 1, 2008.
- (2) However, also provides an exception that if House Bill 2436, 2007 Regular Session (HB 2436), becomes law and also amends GS 115C-302.1(d), then subsection (a) of Section 1 becomes effective July 1, 2009.

Provides that if HB 2436 becomes law, then GS 115C-302.1(d), as amended by Section 26.21 of HB 2436 to expire June 30, 2009, is rewritten to provide that teachers using personal leave are to receive full salary minus the required substitute deduction with the following exceptions: (1) teachers may use up to one day of personal leave per year and receive full salary and (2) teachers using personal leave on non-protected workdays will receive full salary. Provides that this provision expires at the same time as the amendment to GS 115C-302.1(d) made by HB 2436 expires (June 30, 2009).

Except as otherwise provided, effective when it becomes law.
