**H 1593. STATE HEALTH PLAN/CHANGE TO CALENDAR YEAR.** Filed 4/18/07. *TO CHANGE THE PLAN YEAR OF THE TEACHERS' AND STATE EMPLOYEES' COMPREHENSIVE MAJOR MEDICAL PLAN FROM A FISCAL YEAR TO A CALENDAR YEAR.*

Amends GS 135-40.1 as title indicates, effective January 1, 2009. Makes conforming changes throughout Parts 1 through 3 of Article 3 of Chapter 135 of the General Statutes.

**H 1593. STATE HEALTH PLAN/CHANGE TO CALENDAR YEAR.** Filed 4/18/07. House committee substitute makes the following changes to 1st edition. Changes the effective date of the repeal of GS 135-40.1(7b) [defining fiscal year] from January 1, 2009, to when the act becomes law. Modifies proposed amendments to GS 135-40.1 by deleting the proposed definition of *calendar year*, and substituting a definition of *plan year* as an annual period that is established by the Executive Administrator (EA) and Board of Trustees (BT) under proposed GS 135-39.5C. Enacts new GS 135-39.5C to direct that the *plan year* is to be July 1 through June 30 of the following year unless it is changed to a calendar year by the EA and BT after consultation with the Committee on Employee Hospital and Medical Benefits. Provides time limits for the initial transition plan and availability of funding restrictions on changing the plan year. Effective when the act becomes law, (was, January 1, 2009), directs the Revisor of Statutes to delete the term *fiscal year* wherever it appears in Parts 1 through 3 of GS Chapter 35, Article 3, except in GS 135-39.6 (special funds created), and replace it with *plan year* (was, calendar year).

**H 1593. STATE HEALTH PLAN/PLAN YR. CHANGE (NEW).** Filed 4/18/07. Senate committee substitute deletes the provisions of the 2nd edition and replaces it with *AN ACT TO DIRECT THE EXECUTIVE ADMINISTRATOR OF THE TEACHERS' AND STATE EMPLOYEES' COMPREHENSIVE MAJOR MEDICAL PLAN TO PREPARE TO CHANGE THE STATE HEALTH PLAN FROM A FISCAL YEAR TO A CALENDAR YEAR.* Requires the Executive Administrator of the Teachers' and State Employees' Comprehensive Major Medical Plan to evaluate the actuarial, administrative, financial, operational, and plan member impact of converting the Plan's benefit plan year from a fiscal year to a calendar year basis and to report to the Committee on Employee Hospital and Medical Benefits and the Fiscal Research Division by April 1, 2008. Specifies information that must be included in the report.
