H 1685. ADULT CARE HOME RELOCATION. Filed 4/18/07. *TO AMEND THE CERTIFICATE OF NEED REQUIREMENTS TO ALLOW AN ADULT CARE HOME TO RELOCATE WITHIN THE SAME COUNTY WITHOUT HAVING TO OBTAIN A CERTIFICATE OF NEED.*

Amends GS 131E-176(5) (definition of *change in bed capacity*) and GS 131E-176(16)q. (definition of *new institutional health services*) to provide that when an adult care home relocates its adult care home beds within the same county it does not constitute a new institutional health service and does not require a certificate of need, as long as the relocation does not increase the number of adult care home beds.

H 1685. ADLT CARE HOME OR NURSING HOME/EXPEDITED CON (NEW). Filed 4/18/07. House committee substitute makes the following changes to 1st edition. Deletes the provisions of the 1st edition. Requires the Department of Health and Human Services, Division of Facility Services, to develop an expedited certificate of need review process no later than October 1, 2007, for current certificate holders for an adult care home or a nursing home to relocate from one licensed facility or campus to another. The certificate of need review process is available only to facilities that meet the criteria specified in the bill. The act applies to certificate of need applications for the relocation of adult care homes and adult care home beds within the same county filed on or after the date of the implementation of the expedited review process. Amends the title to include nursing homes.

H 1685. ADLT CARE HOME OR NURSING HOME/EXPEDITED CON. Filed 4/18/07. Senate amendment makes the following changes to 2nd edition. Requires the Department of Health and Human Services to report to the General Assembly by May 1, 2008, on the minimum review criteria necessary to determine the need for a relocation of a facility that qualifies for an expedited certificate of need. Corrects the name of the Division of Health and Service Regulation.

SL 2007-473 (H 1685). ADULT CARE HOME OR NURSING HOME/EXPEDITED CERTIFICATE OF NEED. *AN ACT TO AMEND THE CERTIFICATE OF NEED REQUIREMENTS TO ALLOW FOR AN EXPEDITED REVIEW PROCESS FOR AN ADULT CARE HOME OR A NURSING HOME TO RELOCATE WITHIN THE SAME COUNTY.* Summarized in *Daily Bulletin* 4/18/07, 5/17/07, and 7/28/07. Enacted August 29, 2007. Effective August 29, 2007, and applies to certificate of need applications for the relocation of adult care homes and adult care home beds or nursing homes and nursing home beds within the same county filed on or after the date of implementation of the expedited review process by DHHS, Division of Health Service Regulation.
