H 18. DEFINE RESIDENCE FOR STUDENT W/SPECIAL NEEDS. Filed 1/25/07. *TO IMPLEMENT A RECOMMENDATION OF THE HOUSE SELECT COMMITTEE ON THE EDUCATION OF STUDENTS WITH DISABILITIES TO CLARIFY THE DEFINITION OF RESIDENCE FOR THE DELIVERY OF SPECIAL EDUCATION SERVICES.* Adds new subdivision (18a) to GS 115C-106.3 defining "residence" or "reside" to mean the local educational agency (LEA) where the child with disabilities lives and meets the school admission requirements specified in GS 115C-366 (assignment of student to a particular school). Provides an exception for children with disabilities to the age requirements in GS 115C-366. Exempts from this definition children with disabilities enrolled in a particular LEA as of the last day of the 2006-07 school year as long as they continue to live within and remain enrolled in the LEA.

H 18. DEFINE RESIDENCE FOR STUDENT W/SPECIAL NEEDS. Filed 1/25/07. Senate committee substitute makes the following changes to 1st edition. Modifies proposed new GS 115C-106.3(18a) to clarify the definition of residence or reside and provides that the definition does not apply to children with disabilities who were (1) enrolled in a particular local school administrative unit on the last day of school for the 2006-07 school year or (2) enrolled in and attending a school in a particular local school administrative unit on August 1, 2007, for the 2007-08 school year for as long as they live within and are continuously enrolled in that local school administrative unit (was, does not apply to children with disabilities who were enrolled in a particular local educational agency on the last day of school for the 2006-07 school year for as long as they live within and are continuously enrolled in that local educational agency). Amends GS 115C-106.2(a) to clarify that Article 9 applies to children with disabilities who reside in the state. Amends GS 115C-107.3(a) to provide that the annual census is of children with disabilities residing in the state. Amends GS 115C-107.6(b) to prohibit a child with disabilities from being prevented from attending the public schools in the local educational agency in which the child (was, the child's parents or legal guardian) resides.
