H 189. ROANOKE RAPIDS PYROTECHNICS. Filed 2/14/07. PROVIDING THAT THE GOVERNING BODY OF THE CITY OF ROANOKE RAPIDS MAY AUTHORIZE THE USE OF PYROTECHNICS WITHIN THE CORPORATE LIMITS OF THE CITY AND MAY ISSUE PERMITS FOR THE USE OF PYROTECHNICS. Amends GS 14-410(a) to require written authority from the governing body of the City of Roanoke Rapids for pyrotechnics to be exhibited, used, or discharged within the City of Roanoke Rapids. Amends GS 14-413 to allow the governing body of Roanoke Rapids to issue permits for the use of pyrotechnics in concerts or public exhibitions after receiving evidence that the pyrotechnics will be used only for purposes allowed by law. Prohibits the governing board of the City of Roanoke Rapids from issuing permits for the indoor use of pyrotechnics unless the local or state fire marshal has made the required certification. **H 189. PYROTECHNICS PERMITS BY CITIES (NEW).** Filed 2/14/07. House committee substitute makes the following changes to 1st edition. Changes title to *AN ACT PROVIDING THAT A BOARD OF COUNTY COMMISSIONERS MAY AUTHORIZE THE GOVERNING BODY OF A CITY TO AUTHORIZE THE USE OF PYROTECHNICS WITHIN THE CORPORATE LIMITS OF THE CITY AND ISSUE PERMITS FOR THE USE OF PYROTECHNICS.* Changes the act from a local act granting Roanoke Rapids the authority to issue pyrotechnics permits to a public law that permits any board of county commissioners, by resolution, to authorize the governing body of any city in the county to issue permits authorizing the use of pyrotechnics within the corporate limits of the city. Makes other conforming and technical changes.
