**H 2156. TOWN OF LELAND OCCUPANCY TAX.** Filed 5/15/08. *TO AUTHORIZE THE TOWN OF LELAND TO LEVY A ROOM OCCUPANCY TAX.*

Authorizes the town council of Leland to levy a room occupancy tax of up to 3%. Provides that the tax must be levied, administered, collected, and repealed as provided in GS 160A-215 (uniform provisions for room occupancy taxes). Requires the Town of Leland Tourism Development Authority (TDA) to use at least two-thirds of the occupancy tax proceeds to promote travel and tourism in the town and the remainder for tourism related expenditures. Mandates that at least one-third of the members of the TDA must be affiliated with businesses that collect the tax in the town and at least one-half must be currently active in the town's travel and tourism promotion.

**H 2156. TOWN OF LELAND OCCUPANCY TAX.** Filed 5/15/08. House committee substitute makes the following changes to 1st edition. Amends GS 160A-215(g) (uniform provisions for room occupancy taxes) to add Leland to the list of towns to which that section applies.

**H 2156. LELAND AND MOUNT HOLLY OCCUPANCY TAX (NEW).** Filed 5/15/08. Senate committee substitute makes the following changes to 2nd edition. Authorizes the City of Mount Holly to levy a 3% room occupancy tax, in addition to the Town of Leland. Reorganizes, adds section titles, and adds Mount Holly occupancy tax provisions related to the authorization, scope, and administration, of the tax, the distribution and use of tax revenue, the establishment of a Tourism Development Authority, and reporting to the city council. Requires at least two-thirds of the tax proceeds to be used to promote travel and tourism in Mount Holly, with the remaining to be used for tourism-related expenditures. Makes a conforming change to GS 160A-215(g).

Changes the title to *AN ACT TO AUTHORIZE THE TOWN OF LELAND AND THE CITY OF MOUNT HOLLY TO LEVY A ROOM OCCUPANCY TAX.*

**H 2156. LELAND OCCUPANCY TAX (NEW).** Filed 5/15/08. Senate amendment makes the following changes to 3rd edition. Removes all provisions related to the Mount Holly occupancy tax that were added in the third edition. Makes technical and conforming changes, including a title change.
