H 2367. INVOLUNTARY ANNEXATION MORATORIUM. Filed 5/20/08. TO ADOPT A MORATORIUM ON INVOLUNTARY ANNEXATIONS, AS RECOMMENDED BY THE HOUSE SELECT COMMITTEE ON MUNICIPAL ANNEXATION.

Provides that no annexation resolution of consideration, resolution of intent, or ordinance may be adopted from the date this act become effective until June 30, 2009. If an ordinance has already been adopted with an effective date after the date this act become effective, then the ordinance's effective date is delayed to after June 30, 2009. If a municipality has already adopted a budget ordinance for 2008-09 and this act causes the assessed valuation estimate to be reduced, the municipality may amend the budget ordinance to account for this act, including establishing a different tax rate.

H 2367. INVOLUNTARY ANNEXATION MORATORIUM. Filed 5/20/08. House committee substitute makes the following changes to 1st edition. Deletes a provision that from the day the act becomes law until June 30, 2009: (1) prohibited the adoption of a resolution of consideration, resolution of intent, or annexation ordinance and (2) tolled any annexation proceeding initiated prior to the act effective date that had not yet resulted in adoption of an ordinance.

Changes the involuntary annexation moratorium end date from June 30, 2009, to April 30, 2009.

Changes the effective date to July 31, 2008.

H 2367. INVOLUNTARY ANNEXATION MORATORIUM. Filed 5/20/08. House amendment makes the following changes to 2nd edition. Creates a new Section 1 that from the day the act becomes law until May 31, 2009: (1) prohibits the adoption of a resolution of consideration, resolution of intent, or annexation ordinance and (2) tolls any annexation proceeding initiated prior to the act's effective date that has not yet resulted in adoption of an ordinance. Provides that this section does not prohibit municipalities from developing policies, planning, collecting data, or developing materials with respect to potential future annexations. Renumbers sections accordingly.

Changes the involuntary annexation moratorium end date from April 30, 2009, to May 31, 2009.

Changes the effective date of the act from July 31, 2008, to August 31, 2008.
