**H 2487. CHANGE FORMAT OF DRIVERS LICENSES/ UNDER 21.** Filed 5/21/08. *TO CHANGE THE FORMAT OF A DRIVERS LICENSE OR SPECIAL IDENTIFICATION CARD BEING ISSUED TO A PERSON LESS THAN TWENTY-ONE YEARS OF AGE FROM A HORIZONTAL FORMAT TO A VERTICAL FORMAT TO MAKE RECOGNITION OF UNDERAGE PERSONS MORE EASY FOR CLERKS DEALING IN RESTRICTED AGE SALES OF PRODUCTS SUCH AS ALCOHOLIC BEVERAGES AND TOBACCO PRODUCTS AS RECOMMENDED BY THE CHILD FATALITY TASK FORCE.*

Amends GS 20-7(n) as title indicates. Also directs that licenses and special identification cards issued to applicants 21 years or older be printed in a horizontal format. Effective October 1, 2008.

**H 2487. CHANGE FORMAT OF DRIVERS LICENSES/UNDER 21.** Filed 5/21/08. House committee substitute makes the following changes to 1st edition. Clarifies that the act applies to drivers licenses and special identification cards issued or renewed on or after the effective date of October 1, 2008.

Requires the Office of State Controller, with the support of the Office of State Budget, to identify and work to secure matching funds or other resources to assist in funding the change of the driver's license format for drivers under 21 years of age. Makes technical changes.

Amends provisions of GS 20-7(f) to provide that drivers licenses issued to drivers under the age of 21 expire on the driver's 21st birthday (now, licenses issued to drivers under 18 expire on the driver's 21st birthday).
