H 27. DUTY TO REPORT CHILD PORN. Filed 1/29/07. *TO PROVIDE THAT A RETAIL OR WHOLESALE FILM PROCESSOR, PHOTO FINISHER, OR COMPUTER TECHNICIAN WHO, IN THE COURSE OF WORK, ENCOUNTERS AN IMAGE OF A MINOR ENGAGING IN SEXUAL ACTIVITY MUST REPORT THE NAME OF THE CUSTOMER REQUESTING THE DEVELOPMENT OF THE FILM OR IN POSSESSION OF THE COMPUTER TO THE NATIONAL CENTER FOR MISSING AND EXPLOITED CHILDREN AND TO THE APPROPRIATE LOCAL LAW ENFORCEMENT OFFICER.* Amends GS Chapter 14, Article 26 by adding a new GS 14-190.25 as title indicates. Provides a person acting in compliance with the statute immunity from any civil or criminal liability. Makes conforming changes to GS 14-190.13. Effective December 1, 2007.

H 27. DUTY TO REPORT CHILD PORN. Filed 1/29/07. House committee substitute makes the following changes to 1st edition. Deletes all provisions of the 1st edition and replaces it with *A BILL TO BE ENTITLED AN ACT TO PROVIDE THAT A FILM AND PHOTOGRAPHIC PRINT PROCESSOR OR A COMPUTER TECHNICIAN WHO, IN THE PERSON'S SCOPE OF EMPLOYMENT, OBSERVES AN IMAGE OF A MINOR OR A PERSON WHO REASONABLY APPEARS TO BE A MINOR ENGAGING IN SEXUAL ACTIVITY MUST REPORT THE NAME OF THE PERSON REQUESTING THE PROCESSING OF THE FILM OR PHOTOGRAPHS OR IN POSSESSION OF THE COMPUTER TO THE NATIONAL CENTER FOR MISSING AND EXPLOITED CHILDREN OR TO THE APPROPRIATE LOCAL LAW ENFORCEMENT OFFICER.* Enacts new GS 66-67.4 as title indicates. Provides that an employee of a film and photographic print processor or computer technician may meet the requirements of this act by reporting the required information to a person designated by the employer to make such reports under this act. Provides a person acting in compliance with the statute immunity from any civil or criminal liability. Effective July 1, 2007.

H 27. DUTY TO REPORT CHILD PORN. Filed 1/29/07. Senate committee substitute makes the following changes to 2nd edition. Modifies proposed new GS 66-67.4 to replace the definition of *film and photographic print processor* with a definition of *processor of photographic images*. Makes conforming changes.
