H 429. OCEAN ISLE BEACH CANAL DREDGING FEE. Filed 2/28/07. *TO CLARIFY THE OCEAN ISLE BEACH CANAL DREDGING FEE.*

Amends Section 3 of SL 2004-104 to allow Ocean Isle Beach to impose canal dredging fees on owners by applying the assessment procedure in GS 160A-218.

H 429. BEACH TOWNS/CANAL DREDGING FEE (NEW). Filed 2/28/07. House committee substitute makes the following changes to 1st edition. Corrects title to reflect that the act applies to the towns of Emerald Isle and Holden Beach as well as to Ocean Isle Beach. Provides that canal dredging fees must be made on the basis of the frontage abutting the project at an equal rate per foot of frontage or per unit or parcel of property (was, by using the basis and procedures for making special assessments in GS 160A-218).

H 429. CANAL DREDGING FEE/BRUNSWICK FIRE FEES (NEW). Filed 2/28/07. Senate committee substitute makes the following changes to 2nd edition. Amends SL 1999-323, as amended, as follows, effective January 1, 2008. Amends the fees that Brunswick County may charge for fire protection services for single-family dwellings or manufactured or mobile homes, unimproved land, and commercial facilities by changing the maximum on some of the existing fees and adding new fees. Requires a fire department that the county has contracted with for fire protection services in a fee-supported fire district to contract for quarterly bookkeeping/accounting services, pre-approved by the County Finance Officer, for each fiscal year and sets other accounting requirements. Requires each nonmunicipal department to bring any purchase exceeding \$10,000 to a fire protection oversight board for approval. Provides for the assumption of debt when a portion of a fee-supported fire district is annexed by a municipality furnishing fire protection. Requires departments receiving funding from a fee-supported district to participate in a countywide strategic planning session at least once a year. Allows the county to foreclose fire fee liens under any procedure provided for by law for the foreclosure of property tax liens.

H 429. CANAL DREDGING FEE/BRUNSWICK FIRE FEES. Filed 2/28/07. Senate amendment makes the following changes to 3rd edition. Corrects a technical error made in the version of SL 1999-323 Section 1(c)(4)e set out in the bill.

SL 2007-335 (H 429). CANAL DREDGING FEE/BRUNSWICK FIRE FEES. AN ACT TO AUTHORIZE THE TOWNS OF OCEAN ISLE BEACH, EMERALD ISLE, AND HOLDEN BEACH TO SET CANAL DREDGING FEES BASED ON A PROPERTY OWNER'S FRONTAGE ABUTTING A DREDGING PROJECT, AND TO MODIFY BRUNSWICK COUNTY'S FIRE PROTECTION FEES. Summarized in *Daily Bulletin* 2/28/07, 3/29/07, 7/25/07, and 7/26/07. Enacted August 2, 2007. Section 2 is effective January 1, 2008. The remainder is effective August 2, 2007.
