TO AUTHORIZE THE SECRETARY OF HEALTH AND HUMAN SERVICES TO SUSPEND ADMISSIONS OR SERVICES IN HOSPITALS AS PART OF TAKING ADVERSE ACTION AGAINST A HOSPITAL'S LICENSE; TO ALLOW FOR THE WAIVER OF HOSPITAL LICENSURE RULES DURING AN EMERGENCY; TO ALLOW CRIMINAL BACKGROUND CHECKS OF EMPLOYEES OF LICENSED MENTAL HEALTH FACILITIES BY PRIVATE ENTITIES; TO MAKE TECHNICAL CORRECTIONS IN THE HEALTH CARE PERSONNEL REGISTRY STATUTES; TO REQUIRE FINES TO BE PAID PRIOR TO TRANSFER OF OWNERSHIP OF ADULT CARE HOMES; AND TO CHANGE TIME FRAMES OF INVESTIGATIONS OF ADULT CARE HOMES.

Amends GS 131D-26(a1) to require investigations conducted by a county department of social services to be completed within 60 days (previous language removed the requirement that the investigation be completed within 30 days).

**H 772. LICENSURE CHANGES/HOSP. ADULT CR. HMS., MH.** Filed 3/14/07. Senate committee substitute makes the following changes to 3rd edition. Further amends GS 122C-80(b) and amends GS 131D-40 and GS 131E-265 to define the term *private entity* to mean a business regularly engaged in conducting criminal history checks utilizing public records obtained from a state agency. Directs the Codifier of Rules to make name changes in the Administrative Code, replacing *Division of Facility Services* with *Division of Health Service Regulations*, and replacing *Health Services Commission* with *Commission for Public Health*. Makes technical and conforming changes.
